

### 5.1 Introduction

There are many different public agencies; federal, state, and local governments; nonprofit organizations; institutions; and individual citizens who have an interest in the future management of Valley Forge NHP. Reaching out to these interested parties for their ideas and expertise and listening to their concerns is an important step in the development of a GMP/EIS. A combination of activities, including formal public workshops, stakeholder interviews, government briefings, and agency meetings, has helped the park and its planning team gain valuable insight in developing alternatives for the future of Valley Forge NHP.

This chapter describes the public involvement and agency coordination used during the preparation of this Draft GMP/EIS. It provides a detailed list of the various consultations held during the scoping and alternatives development phases of the project, and it also provides the list of recipients for this document.

### 5.2 Public Involvement

Since the beginning of the planning process for the Valley Forge NHP GMP/EIS, the park and its planning team reached out to stakeholders including the general public, interested individuals, local governments, organizations, and any agencies having jurisdiction by law or expertise for assistance in determining the scope of issues that should be addressed. As the development of alternatives progressed, the park provided information and updates via newsletters, news releases, public open houses, the park website, and briefings. Table 5-1 provides a running list of the consultations and public involvement activities. For a summary of the comments received during the scoping process, see Appendix C: Scoping Summary and Analysis. Also, Appendix B contains relevant correspondence with agencies and American Indian tribes.

### 5.3 Tribal Coordination

At the onset of the GMP/EIS process and prior to public review of the Draft GMP/EIS, the Oneida Indian Nation (New York) was contacted via letter to request formal consultation (August 8, 2002 and March 23, 2006). The Oneida were present during the 1777-78 encampment and maintain an oral tradition of their experiences with the soldiers. Twice a year, the Oneida visit Valley Forge NHP to present interpretive programs focused on their experiences during the encampment. The Oneida also meet with park staff at this time to review upcoming proposals and interpretive relationship with the Oneida Indian Nation (New York), which will continue as the new GMP is implemented.

Additional American Indian tribes were contacted via letter to initiate consultation, including the Oneida Nation of Wisconsin, the Stockbridge-Munsee Community, and the Delaware Nation. Consultation and coordination with these tribes will continue through implementation of the new GMP, as needed. This effort will also be continued through the Section 106 compliance process.

### 5.4 Section 106 Consultation

Section 106 of the National Historic Preservation Act of 1966, as amended requires that federal agencies consider the effect of undertakings on properties listed on the National Register and allow the SHPO and ACHP the opportunity to comment. On August 1, 2002, Valley Forge NHP sent letters to both the Pennsylvania SHPO and the ACHP to initiate consultation for the GMP/EIS. The SHPO acknowledged the request for consultation with a letter dated September 11, 2002. Informal meetings with the SHPO and staff have occurred throughout the planning process, with official updates being provided at the annual site review meetings on April 27, 2004 and May 11, 2005.

To further compliance with Section 106, the park has prepared a draft Programmatic Agreement. The Programmatic Agreement lists the potential actions that may require further compliance with Section 106 of the NHPA and identifies the necessary steps the NPS will take prior to implementation. The draft Programmatic Agreement is located in Appendix G and Table F-1 also identifies those proposed actions that will require additional compliance with Section 106.

### 5.5 Section 7 Consultation

Section 7 of the Endangered Species Act of 1973, as amended (16 USC 1531 et seq.) requires all federal agencies to consult with the USFWS to ensure that any action authorized, funded, or carried out by the agency does not jeopardize the continued existence of listed species or critical habitat. NPS management policies also require cooperation with appropriate state conservation agencies to protect state-listed and candidate species of special concern within park boundaries.

At the onset of the GMP/EIS, the park contacted the USFWS and the Pennsylvania Natural Diversity Inventory (as administered by the Pennsylvania Department of

Conservation and Natural Resources) via letter to initiate consultation and request information about special status species within Valley Forge NHP (August 7, 2002). The USFWS noted that habitat for the federally threatened bog turtle (*Clemmys muhlenbergii*) exists within the park. In a letter dated October 29, 2002, the agency requested a habitat suitability survey if wetlands occur within or near areas of proposed impact. Actions proposed by the Valley Forge NHP GMP have been designed to avoid and/or minimize adverse impacts to wetlands. However, as individual actions are implemented, the park will survey the area for suitable habitat and coordinate with the USFWS, as needed.

The review by the Pennsylvania Natural Diversity Inventory (letter dated March 14, 2003) indicated several occurrences of state species of special concern within Valley Forge NHP (see Table 3-2 for a list of species and correspondence in Appendix B). As with the bog turtle, actions proposed by the GMP have been designed to avoid and/or minimize adverse impacts to these species and their habitats. As individual actions are implemented, the park will survey the specific area of potential impact and coordinate with the appropriate state agency (Pennsylvania Department of Conservation and Natural Resources, the Pennsylvania Fish & Boat Commission and/or the Pennsylvania Game Commission), if species are encountered.

### 5.6 Transportation Planning Process

The NPS has worked for many years with federal and state transportation agencies to protect the resources within Valley Forge NHP. In order to work together more effectively, a Memorandum of Understanding among the NPS, FHWA, PennDOT, the Pennsylvania Historical and Museum Commission, and the DVRPC was signed in March 2002 "to promote the long-term protection of the resources and values of Valley Forge National Historical Park and to achieve regional transportation goals." Since then, over 200 meetings have been held with officials and the public to identify transportation related issues, develop proposed solutions, program funds, and plan for implementation of the identified transportation projects. (Please see Appendix A for a copy of the Memorandum of Understanding.)

Through this cooperative effort, these agencies worked with the townships, counties, and elected officials to complete the VFATPS. This study provided recommendations for further action in September 2002 and was the basis for a Programmatic Agreement between the NPS and FHWA in December 2002. This agreement outlined a plan for implementation for the VFATPS recommendations. The study was coordinated closely with the *Phoenixville Area Intermodal Transportation Study* that was completed by DVRPC in January 2003. (Please see Appendix A for a copy of the transportation Programmatic Agreement.)

During the study process, a steering committee was formed among the project sponsors including the NPS, FHWA, PennDOT, and DVRPC. A larger advisory committee was formed to include project stakeholders such as West Norriton, Upper Merion, Lower Providence, Tredyffrin, and Schuylkill Townships, Chester and Montgomery Counties, SEPTA, the Greater Valley Forge TMA, and the Chester County TMA. Between March and September 2002, three meetings were held to solicit input from the advisory committee.

A public open house was held June 25, 2002 to present the range of options being considered in the VFATPS. A second public meeting was held July 23, 2003 as part

of the GMP/EIS scoping process, at which transportation and site access issues were identified by the public as one of the key issues to be addressed by the GMP/EIS.

The steering committee met 14 times between February 2002 and July 2003. Over 30 smaller meetings were held with various members of the steering committee during the planning study phase. During this phase of the VFATPS, several specialized groups were formed to focus on key issues that were critical to the advancement of the initiatives recommended for further study. These work groups included

- NEPA process work group
- funding and implementation work group
- Betzwood Bridge replacement project work group
- GMP/EIS IACM group
- Section 106 coordination work group
- traffic and transportation development committee

More than 50 meetings were held to focus on these key issues through June 2005. Steering committee representatives also held over 50 meetings with project stakeholders to provide updates on the status of these projects and solicit input on transportation improvement initiatives. These efforts resulted in the completion of two early action items based on cooperative effort of the project sponsors. These included a minor widening of North Gulph Road just south of PA Route 23 and improved way-finding signage for Valley Forge NHP along westbound I-76.

The NEPA process work group was charged with identifying the regulatory requirements for implementation of transportation projects by the NPS and FHWA and to develop methods for minimizing duplication of effort. The funding and implementation work group focused on the funding needs for various planning phases and was responsible for coordinating the procurement procedures. The Betzwood Bridge replacement project work group was responsible for identifying and resolving outstanding issues regarding the final design for the Betzwood Bridge replacement.

An IACM group was formed to assess the transportation elements for the GMP/EIS to be consistent with PennDOT's Transportation Project Development Process. The IACM met four times between January 2003 and February 2005 to develop transportation-related purpose and need statements and a preliminary range of transportation elements to be included in the Draft GMP/EIS.

The Section 106 coordination work group consulted with the NPS and the Pennsylvania SHPO to comply with Section 106 of the NHPA. Four Section 106 coordination meetings were held to plan the key tasks for determining the impacts to the cultural resources in the project study area.

The DVRPC worked with PennDOT, FHWA, and the NPS to provide the traffic forecasting for the VFATPS implementation phase. The DVRPC report (March 2005) provided AADT volumes for the current conditions, Design Year 2030 no build, and seven Design Year 2030 build scenarios that were identified by the traffic and transportation development committee.

Once the study was complete, the steering committee began the VFATPS programmatic agreement implementation phase in early 2004. The work included all actions to be carried out as specified in the agreement, including advancement of the RCC projects and the development of the transportation elements that would be considered during the GMP/EIS process.

Steering committee meetings have continued to be held during the implementation phase. After the first advisory committee meeting on September 22, 2004, all parties agreed to merge the steering committee and the advisory committee because several representatives of the advisory committee requested to be more involved in the daily project development activities.

During the implementation phase, public meetings were held on September 30, 2004 and June 28, 2005 to present the progress on the RCC projects and provide general information regarding the GMP/EIS.

In April 2005, the project sponsors and affected municipalities coordinated a group trip to Washington, D.C. to present the projects to the elected officials and gain support for the projects outlined in the VFATPS programmatic agreement.

Coordination for the transportation-related activities as outlined in the VFATPS programmatic agreement is expected to continue through mid-2006.

#### 5.7 Document Review and List of Recipients

#### 5.7.1 **Review Process for Draft GMP/EIS**

This Draft GMP/EIS for Valley Forge NHP will be on public and agency review for 60 days. During the review period, the team will solicit public and agency comment and will hold public meetings that will be advertised in local media outlets. Once comments are received and analyzed, a Final General Management Plan/Environmental Impact Statement (or Abbreviated Final Environmental Impact Statement if comments are not substantive) will be prepared that will respond to and incorporate the public comments on the draft document. After a 30-day no-action period, a Record of Decision (ROD) will be prepared to document the selected alternative and set forth any stipulations for implementation of the General Management Plan, thus completing the NEPA compliance requirements.

As noted previously in the document, this Draft GMP/EIS presents an overview of potential actions and impacts related to the management objectives. More detailed plans may be developed for individual actions outlined under each objective, and these plans may require and would be subject to additional environmental compliance reviews, such as NEPA and Section 106 of the NHPA, as amended.

Appendix F provides a list of potential actions associated with the NPS Preferred Alternative and whether or not they may require additional compliance.
