- **GGNRA Compendium (Appendix B)** Compendium shown in Appendix B (June 14, 2012) is not the current compendium. Current compendium (July 15, 2013) is listed separately on the PEPC web site.
- Presidio Trust Commercial Dog Walking proposed action –the description of the Presidio Trust's proposed action in the draft plan/SEIS is not current. The Trust is currently considering an interim regulation that would be enacted in concert with the interim restriction being considered by GGNRA. ## Maps:

- Fort Mason Maps 9-B,C,D,E,F: On-leash shading in eastern section of Fort Mason incorrectly includes fenced residential areas in the NE section and does not include open areas outside of housing in the SE section. Correct shading should have included all "open areas around housing" as stated in the alternatives matrix on page x in the Summary in Volume I.
- Fort Funston Maps 16 A-F: The Battery Davis Trail between Battery Davis and the Sunset Trail no longer exists.
- Fort Funston Maps 16 C,D,E,F: Funston Beach Trail (North) should connect to area open to dog walking on the beach.
- o Fort Funston Maps 16 E, F: The upland ROLA includes the section of the Sunset Trail that is between the intersections with the Chip Trail and Funston Road.
- Fort Point Maps 11 A, B, C, E, F: On-leash dog walking is permitted in the grassy area surrounding the restroom below the parking lot located adjacent to the fort.
- Rodeo Beach Maps 6 A-F: The small access point (a proposed stairway) at the north end of the beach has not been planned yet, but is mistakenly shown on these maps.
- Cattle Hill/Sweeney Ridge Maps 19 A-F: The Mori Ridge Trail which runs between the Shelldance Nursery trailhead and the intersection with the Notch Trail on Sweeney Ridge is mislabeled as the "Sweeney Ridge Trail".
- Cattle Hill/Sweeney Ridge Maps 19 E, F: The NPS-owned portion of Sneath Lane extends to the gate and parking area near the community, as shown by the on-leash shading in Map 19A. The on-leash dog shading on Maps E and F should extend to the same point as in Map 19 A.
- Chapter 2, Table 4: Environmental Impact Summary by Alternative The rationale given for Visitor Use and Experience/Visitors who prefer to bring dogs to the park (page 247), is incorrect does not match the text, as summarized in the Rancho Corral de Tierra Alternative A Conclusion Table on page 1200.
