I'm not seeing a place to enter in our comments so our response would be:

Based on the information received and available within our files, we concur with the findings of the agency that the Henry Wright House (Key No. 210155) is Not Eligible for listing in the National Register of Historic Places, either individually or as a contributing resource, under Criterion A, B, or C, due to a lack of integrity and significance. The property has not been assessed under Criterion D as part of the current investigations.
