

Scoping Report Organization and Overview

This scoping report contains eight sections of information (Tabs 1-8) that allow the reader to easily navigate the document.

Tab 1, **Scoping Summaries**, contains two pieces of information: GMP Scoping Executive Summary and Scoping Comment Code Summary. The GMP Scoping Executive Summary summarizes the results of GMP scoping. The Scoping Comment Code Summary is organized by scoping code and presents more detail on the information gathered from internal (NPS staff) and external (public) scoping. The major themes, issues, and common concerns have been captured in these summaries. Common concerns are those that were repeated by numerous respondents.

Tab 2, **Mapping Exercise Summary**, summarizes the results of a mapping exercise conducted at public scoping meetings that focused on “Special Places” and “Problem Locations”. The results are presented by location among park units and include public comments.

Tab 3, **Focus Group Meeting Summaries**, includes summaries of meetings held with the following focus groups: Founders and Former GGNRA Advisory Commission members; Ohlone Community/Federated Indians of Graton Rancheria; Historic, Diversity and Environmental representatives; and Alcatraz Vision Team. To provide the reviewer with a comprehensive understanding of individual meetings, focus group information is presented in meeting note format and is not included in the detailed scoping database contained in Tab 7.

Tab 4, **Newsletter Comment Form and Public Response**, contains two pieces of information: the Newsletter Comment Form, which was included in the GMP scoping newsletter and was the primary vehicle for receiving public comment, and the Public Responses to the seven questions listed on the comment form.

Tab 5, **Agency Workshop Meeting Summary, Issue Forms and Letters**, contains three pieces of information: Agency Roundtable Meeting Notes, Issue Forms, and Letters. The Meeting Notes are a summary of information from the Agency Roundtable meeting. The Issue Forms were filled out by individuals attending the Agency Roundtable meeting. This tab also includes Letters that were submitted by The Presidio Trust and the City of Pacifica’s GGNRA Liaison Committee.

Tab 6, **Letters from the Public**, includes letters and e-mails received from members of the general public. These letters were either too lengthy to code or contained particular information that should be reviewed by the GMP Planning Team.

Tab 7, **Scoping Data**, contains two pieces of information: Scoping Comment Codes and Scoping Data. The Scoping Comment Codes is a listing of all of the codes that were created to analyze the volume of information obtained during scoping. The Scoping Data is organized by scoping comment code and includes all of the comments and information obtained during the scoping process, both internal and external.

Tab 8, **Park Conservancy & NPS Scoping**, contains meeting notes from discussions with the Golden Gate National Parks Conservancy, NPS staff, and working groups. This information is included in the detailed scoping database contained in Tab 7.
