Buenas Yan Hafa Adai,

The National Park Service (NPS) is pleased to announce the launch of a study of the unique natural and cultural resources of the island of Rota (Luta) in the Commonwealth of the Northern Mariana Islands (CNMI).

As directed by the U.S. Congress, at the request of Representative Gregorio Kilili Camacho Sablan, we are conducting a study of Rota's prehistoric and historic resources and limestone forests. The Rota Special Resource Study will evaluate the national significance of the area and the suitability and feasibility of designating the area as a unit of the national park system (P.L. 113-291 Section 3051, December 19, 2014).

This study will take place over the next two to three years. It will begin with gathering information about Rota's resources through research and community engagement and will conclude with study findings that are transmitted to the U.S. Congress. It will be up to Congress, in collaboration with the CNMI government, to choose whether to take an action, regardless of the results of the study.

During this early stage, the NPS would like to understand your thoughts, ideas, and wishes for Rota's special places. We invite you to attend public meetings in February 2017 to learn more about this study and the NPS, and to share your thoughts with us. If you cannot attend a meeting in person, you can send us your comments. See page 15 for the schedule of public meetings and information on how you can provide comments.

Your thoughts and ideas are important to the study. We look forward to meeting and hearing from you!

About the National Park Service

The National Park Service is a U.S. federal agency, charged with managing more than 400 units of the national park system, including national parks, monuments, historic sites, and a variety of other unit types, in all 50 states, the District of Columbia, American Samoa, Guam, Puerto Rico, Saipan, and the Virgin Islands. Administration of park units occurs in many ways, from traditional units which are federally managed, to non-traditional units, which rely on partnerships and may have little, if any, federal landownership.

The National Park Service preserves unimpaired the natural and cultural resources and values of the national park system for the enjoyment, education, and inspiration of this and future generations. The treasures in this system have been set aside by the American people to protect, preserve, and share our nation's greatest stories. The NPS cooperates with partners to extend the benefits of natural and cultural resource conservation and outdoor recreation throughout this country and the world.

What is a Special Resource Study?

A Special Resource Study (SRS) evaluates the eligibility of an area to be designated as a national park or other special designation. The National Park Service collects information about the quality of resources in the study area. If the resources meet the eligibility criteria, the NPS will evaluate the potential for visitor enjoyment and efficient management, and will analyze the feasibility and appropriateness of different management options. The NPS provides its findings to the Secretary of the Interior who then presents a recommendation to Congress. New units of the national park system can only be established by an act of Congress or by Presidential Proclamation.



For an area to be recommended as an addition to the national park system, it must meet all of the following criteria, established by the 1998 National Parks Omnibus Management Act (*54 United States Code 100507*):


- Contain nationally significant natural and/or cultural resources.
- Represent a natural or cultural resource that is not already adequately represented in the national park system or is not comparably represented and protected for public enjoyment by another land-managing entity.
- Must be (1) of sufficient size and appropriate configuration to ensure long-term protection of the resources and visitor enjoyment, and (2) capable of efficient administration by the National Park Service at a reasonable cost; important feasibility factors include landownership, acquisition costs, life cycle maintenance costs, access, threats to the resource, and staff or development requirements.
- Direct NPS management must be determined to be clearly superior to other management approaches.

Study Process

The NPS study team will evaluate important natural and historic places of Rota based on the criteria listed above. If the area is found to meet all of the criteria, the study team will consider alternative ways that local, CNMI, federal, and private entities can further protect and interpret Rota's important places. These alternatives will also include the option of continuing current management of the area (the “no action” alternative). These alternatives will be developed with input from local stakeholders and officials and explore a range of opportunities and management strategies.

During the study process, the NPS will explore many topics including: significance of Rota's resources, preservation and recognition of prehistoric and historic sites; interpretation of the Chamorro culture, including the relation of traditional Chamorro life to natural resources; protection of native limestone forests; and the needs of the local community.

How Will This Study Affect Local Communities and Private Property?

The NPS will only consider management alternatives that respect and retain the authorities of the CNMI government and private property owners. The NPS seeks to work collaboratively with local communities and agencies. The study team will take into account the desires of private landowners and Rota and CNMI governmental managers, local land use, and cultural practices. Since the NPS cannot own land in the CNMI, no management options would include NPS land ownership. However, there could be potential for a national park unit which is managed through leases, agreements, or other partnership approaches.



The map above generally depicts the natural and cultural resources and protected areas of Rota. The NPS will be evaluating these resources to see if they meet the study criteria.

What Are Some of the Possible Outcomes of the Study?

Over the last 15 years, approximately one in four completed special resource studies have resulted in a recommendation for inclusion in the national park system. Many studies conclude that resources do not meet the required criteria or that existing management, technical or financial assistance, or local, state or private initiatives are preferable to the establishment of a new national park unit.

In the event that the Rota study results in a recommendation from the Secretary of the Interior that areas of Rota warrant addition to the national park system, Congress may or may not act on or follow the recommendation. Other outcomes of the study could include: no change from the existing management structure, local CNMI public and/or private management options, additional NPS technical assistance, or other local, national, or international designations.

NPS and Other Protected Area Examples

THE NATIONAL PARK SYSTEM AND ITS PROGRAMS

National parks are often thought of as large and mostly natural parks like Yosemite and Yellowstone. However, the national park system includes many types of sites including national monuments, national historic sites, and national preserves and reserves. Park units vary in size, types of resources, landownership, and management. The National Park Service (NPS) often refers to all of these sites as “parks,” “national parks,” or “units of the national park system,” regardless of their official title.

New national park units start with very limited budgets and staffing, and often take many years or decades to develop into fully functioning parks. Considerable time and effort goes into planning for the operations of a new park unit, and improvements are made in small pieces over time.

Existing national parks and protected areas have been compiled below that may provide helpful models for how a national park unit on Rota could be structured.



Lao i Nasionat Paseo na Sistema, bula lokkue' lugat nai ti man dånkulu, tat kumo, “munumentu, lugat frenkas, yan naturat siha nai man ma protete-hi.” I lugat Paseo, difrentis na menedong yan guina-ha frenkas yan dueñun tåno' nai ma manene-ha. Todu esti siha må-a agang Nasionat Paseo osino patti gi Nasionat Paseo.

I nuebu na ma disik-ña para Nasionat Paseo, ti bula bayet-ña “budget” gi tutuhon-ña. Lao yanggen sigi mo’na ma adelanta siempre guaha mas taotao-ña anai para uma trata kumo etdichu magahet na Nasionat Na Paseo. The following examples generally include:

- Units or areas located in United States insular areas and tribal land
- Units or areas with all or mostly non-federal land
- Units or areas with government-to-government management structures and/or involvement by local entities

National Park Unit Examples

NATIONAL PARK OF AMERICAN SAMOA, AMERICAN SAMOA

Acreage—8,256, all nonfederal

Water area—2,500 acres

Designation year—1988

Description: The park preserves, protects, and interprets paleo tropical rainforests, coral reef ecosystems, and the Samoan way of life.

Government Status: American Samoa is an insular area of the United States. Landownership is only allowed by native American Samoans.

Land and Management: The National Park of American Samoa is located on village lands. The NPS leases the lands through a 50-year lease agreement with the Governor of American Samoa, and manages the park in partnership with villages. The park has a legal hiring preference for native American Samoan staff, allows traditional subsistence uses (such as agriculture, fishing, and harvesting non-native wildlife), and has the authority to maintain an advisory board.



AMERICAN MEMORIAL PARK, SAIPAN, CNMI

*Acreage—133, all nonfederal
Designation—Affiliated Area
of the National Park System
Designation year—1978*

Description: American Memorial Park honors those who died during the Marianas Campaign of the Pacific Theater of World War II. The park supports education and appropriate use by the public.

Government Status: The CNMI is an insular area of the United States.

Land and Management: The park land is owned by the CNMI government. The CNMI government leases it to the U.S. Navy, which leases it to the National Park Service, which manages it. A \$2,000,000 trust was established in 1983 by Congress, and the income derived from this fund is used for maintenance and development of the park.

Hafa: I Memorias Amerikano Paseo ha onra todus i man mātai gi duranten i geran dos Pacifiku. I Paseo ha supopot-ta todus asunun edukasion yan siña lokkue' ma usa i lugat para fungsion publiku.

Gubietnamentu: I Gubietnamentun Marianas, patti lokkue' gi papa familiar politika yan i Estados Unidos kumo' "Insular" na lugat.

CANYON DE CHELLY NATIONAL MONUMENT, ARIZONA

*Acreage—83,840, all nonfederal
Designation year—1931*

Description: Canyon de Chelly National Monument preserves one of the longest, continually inhabited locations by American Indian communities in the United States, spanning at least 5,000 years. A resident Navajo community lives within the boundaries of the unit.

Government Status: The Navajo Nation is a sovereign U.S. tribal government and the largest tribal area in the United States.

Land and Management: Canyon de Chelly National Monument is located within the Navajo Nation. Navajo rights, title, and interest are maintained on all lands, minerals,

and the surface use of lands for agriculture, grazing and other purposes. The NPS, Navajo Nation, and the canyon community work in conjunction through an agreement to manage park resources and enable traditional and contemporary lifeways.

SALT RIVER BAY, NATIONAL HISTORICAL PARK AND ECOLOGICAL PRESERVE, ST. CROIX, VIRGIN ISLANDS

*Acreage—989, federal: 225, nonfederal: 765
Designation year—1992*

Description: The preserve contains Amerindian sites, the only known site where members of the Columbus expedition set foot on what is now U.S. territory, and one of the earliest European earthen fortifications in the New World. It preserves upland watersheds, mangrove forests, and estuarine and marine environments.

Government Status: The U.S. Virgin Islands is an insular area of the United States.

Land and Management: The preserve is composed of federal and private lands and is co-managed by the NPS and Government of the Virgin Islands through a cooperative agreement.

Government Status: The Republic of Palau is a sovereign nation in free association with the United States through the Compact of Free Association.

Land and Management: The Rock Islands Southern Lagoon encompasses eight protected areas and is owned by Koror State. The area is a designated conservation zone for multi-use recreation, subsistence, and restricted commercial use. It is part of the Palau's Protected Areas Network, established by the Republic of Palau as a countrywide system of connected protected terrestrial and marine environments. The Koror State Department of Conservation and Law Enforcement manages it, funded by the government of Palau and user fees.



Ongoing National Park Service Involvement on Rota

The National Park Service has been providing Historic Preservation Fund grants to the CNMI since 1974. The CNMI Historic Preservation Office uses these grants for the identification, evaluation, and protection of historic properties, and to fund activities such as, planning, survey and inventory, registration, local and federal project review, acquisition, development, and public education. Additionally, the Historic Preservation Office provides project grants to nonprofit organizations, educational institutions, and private individuals in carrying out historic preservation activities to preserve their cultural heritage.

The NPS has provided technical assistance for historic preservation and awarded grants to the CNMI Historic Preservation Office for projects on Rota. The NPS provided a grant to the CNMI Historic Preservation Office to develop interpretive signs about Rota's historic places, such as at Mochong Latte Village and Rota Sugar Mill. The NPS also provides grants for nominations of historic sites on Rota to the National Register of Historic Places. As Nieves Latte Stone Quarry and Chugai' Pictograph Site are examples of listed national register sites.

In 2005, in response to a request from Rota's senators in the CNMI legislature, the NPS prepared a reconnaissance survey report providing a preliminary analysis of the potential for sites on Rota to be considered for national park designation. The survey report identified potentially significant resources and developed a range of preliminary management options for Rota's resources. The report is being used to inform this larger special resource study.
