# **Proposed Project**

Haleakalā National Park proposes to rehabilitate Kalahaku Overlook for visitor safety and enjoyment and to protect natural and cultural resources.

Kalahaku Overlook consists of a parking area; a vault toilet; four sets of mortared lava rock stairs; and a trail to a partially enclosed structure that overlooks Haleakalā Crater. There is also a separate trail, delineated by a rock wall, west of the parking area that showcases a Haleakalā silversword planting area. The overlook structure, trails, stairs, and rock wall are all considered contributing features to the Haleakalā Highway historic district and are eligible for listing on the State and National Register of Historic Places. Sensitive species in the area include the federally threatened 'āhinahina, or Haleakalā silversword (Argyroxiphium sandwicense subsp. macrocephalum) and the endangered 'ua'u, or Hawaiian petrel (Pterodroma sandwichensis). The Kalahaku Overlook area contains designated critical habitat for the Haleakalā silversword.

Kalahaku Overlook is one of four locations in the park where visitors gather to watch sunrise and sunset and enjoy broad crater vistas. Up to several hundred people may visit the area daily. Options for improvements include delineating and creating visitor use areas; installing interpretive signs; and trail repair.

#### The Environmental Assessment

The NPS will prepare an EA in compliance with environmental and cultural regulations to explore alternatives to meet project objectives; evaluate potential issues and impacts to park resources and values; and identify measures to lessen the degree or extent of these impacts. Consultation with the U.S. Fish and Wildlife Service is required on potential impacts to threatened and endangered species. Consultation with the Hawai'i State Historic Preservation Division is required on potential impacts to cultural resources.

The NPS encourages the public to provide input on the proposed actions, environmental and cultural considerations, potential alternatives, and any other relevant issues that should be considered. Input during the initial phase will be considered during preparation of the EA. The public will have another opportunity to formally comment during review of the draft EA.

# **Alternatives Being Considered**

Various improvements for Kalahaku Overlook are being considered. The EA will include a No Action Alternative and two action alternatives. Alternatives should ensure the safety and enjoyment of park visitors, and the protection of natural and cultural resources. The NPS may include other alternatives, or change the improvements included in the alternatives based on public feedback, implementation feasibility, and potential impacts to resources.

#### **ALTERNATIVE 1: No Action**

• Maintain the status quo. There would be no improvements made to Kalahaku Overlook.

### **ALTERNATIVE 2: Improve Existing Features And Add Viewing Areas**

- Improve the Silversword Trail. Remove asphalt and resurface with local rock and cinder. Repair the adjacent rock wall. Add a crosswalk to indicate best access to and from the parking stalls.
- Increase Designated Viewing Areas into Haleakalā Crater. Construct 1-3 new designated viewing areas along the Haleakalā Crater rim using local rock and cinder.
- Improve Trail Delineations. Clearly delineate existing trails (i.e. Kalahaku Overlook Trail). Delineate the trail terminus at the existing overlook structure. Create and delineate trails to new viewing areas.
- **Install Signage and Barriers**. Add new signage to inform visitors about threatened and endangered species in the area. Install additional signage to remind visitors to stay on marked trails. Install barriers along the south end of the parking area.
- **Install a Fully Accessible Viewing Area**. Construct a viewing platform near the parking area that complies with the Americans with Disabilities Act guidelines. The viewing area may include an interpretive wayside.

### **ALTERNATIVE 3: Improve Existing Features And Add Interpretive Area**

- Improve the Silversword Trail. Remove asphalt and resurface with local rock and cinder. Repair the adjacent rock wall. Add a crosswalk to indicate best access to and from the parking stalls.
- Improve Trail Delineations. Clearly delineate existing trails (i.e. Kalahaku Overlook Trail). Delineate the trail terminus at the existing overlook structure.
- **Install Signage**. Add new signage to inform visitors about threatened and endangered species in the area. Install additional signage to remind visitors to stay on marked trails.
- **Install a Structure for Interpretative Activities**. Construct a structure near the existing overlook structure for ranger-led and self-guided interpretation.
