## Section 1. Project Summary

## PROJECT GOALS AND OBJECTIVES

The goal of the Waterford, Virginia National Historic Landmark (NHL) District Documentation and Update project is to provide the community, the state, and the National Park Service relevant and up-to-date data and information needed to effectively protect and cooperatively manage the NHL district now and for future generations. A corollary goal is to provide students opportunities to gain valuable field experience documenting historic resources and gain knowledge of the National Register and NHL nomination processes. Having these skills will prepare them for employment in the historic preservation field.

In order to accomplish the project goals, the NPS will enter into an agreement with the recipient to perform field documentation of approximately 180 historic properties (including the buildings, sites, objects, and structures) located within the existing Waterford National Historic Landmark District boundary. In addition, the recipient will conduct documentary research, re-evaluate the district's areas of significance, develop historical context, and prepare a revised statement of national significance for the district. The result will be revised and updated National Register/ National Historic Landmark documentation. In addition, the project will result in new or updated entries in Virginia's state historic resources database known as the Virginia Cultural Resources Information System (VCRIS).

## STATEMENT OF PUBLIC PURPOSE

This agreement fulfills the Public Purpose of support and economic stimulation for the following reasons:

- Project will engage recipients, partners, communities, and/or visitors in shared environmental stewardship.
- Project will promote greater public and private participation in historic preservation programs and activities. The project builds resource stewardship ethics in its participants.
- The information, products and/or services identified or developed by this project will be shared through a variety of strategies to increase public awareness, knowledge and support for historic preservation and stewardship of the nation's cultural and historical heritage.
- Project will motivate youth participants to become involved in the natural, cultural and/or historical resource protection of their communities and beyond.
- Students will gain "real world" or hands-on experience outside of the classroom of cultural and/or historical resource projects.
- The scientific community and/or researchers external to NPS gains by new knowledge provided through research and related results dissemination of natural, cultural and/or historical resource information.
- Project assists in the creation, promotion, facilitation, and/or improvement of the public's understanding of natural, cultural, historic, recreational and other aspects of areas such as ecological conservation areas, and state and local parks.

#### STATEMENT OF WORK SUMMARY

Existing historic resource documentation for the Waterford, Virginia National Historic Landmark District is out of date and inadequate to support the effective management of the town's heritage properties. The National Park Service and the University of Delaware's Center for Historic Architecture and Design (CHAD) will partner to develop a detailed research design to accomplish the project goals. Work will consist of research, field documentation, data entry, and analysis of historical materials to establish the historic significance of properties, sites, and landscapes throughout the established district. Descriptive, historical, and photographic documentation for approximately 160 to 180 properties will be updated and entered into the state's historic resources database. A complete National Register of Historic Place registration form will be compiled along with all required attachments, including maps and photographs.

#### RESPONSIBILITIES OF THE PARTIES

- A. The recipient shall be responsible for the following items under this agreement:

- Development of a Research Design in collaboration with the NPS 3.
- 4. Completion of Field Survey & related Data Entry
- 5. **Development of GIS Mapping**
- 6. Historic Research and Development of Historic Contexts
- 7. Build a Resource Inventory for the historic district
- 8. Develop a National Register Nomination including Description and Statement of Significance sections
- 9. Generate required National Register Maps, Photographs, and Other Documentation
- Complete revisions based on an agreed upon draft and revision schedule (established in the Research Design)
- Participate in Meetings & Presentations to share progress, identify and resolve any project issues on a regular basis

Monitor and provide Federal oversight of activities performed under this agreement. Monitoring and oversight includes review and approval of financial status and performance reports, payment request, and tasks identified below. Additional monitoring activities will include site visits, conference calls, and other on-site and off-site monitoring activities. At the Recipient's request, NPS may also provide additional technical assistance to the Recipient in support of the objectives of this agreement.

- 2. Substantial involvement by NPS is anticipated during the period of performance of this agreement. In support of this agreement NPS will be responsible for the following:
  - a. Coordinate with the Waterford Foundation and Loudoun County to provide the Recipient access to the subject property to be nominated. Arrange an initial tour of Waterford with the local historians and preservationists.
  - b. Provide the Recipient with copies of previous research and documentary work done on Waterford, including copies of past documentation projects. NPS will serve as primary liaison with the Virginia State Historic Preservation Office (VA SHPO) and with the Loudoun County Historic Preservation Planner (LC HPP).
  - c. Assist with locating and researching primary and secondary source material.
  - d. Organize and host periodic conference calls with the partner to discuss the progress of the project and to evaluate and resolve research issues.
  - e. Review all materials provided by the Recipient in a timely manner. Provide consolidated comments from NCR staff and peer reviewers.
  - f. Coordinate public outreach activities, including logistics for a public meeting/program, coordinate online venues for posting information on the project and its findings, provide OAH opportunities to present its research to NPS staff and at other public or scholarly venues.
  - g. NPS will also provide opportunities for the Recipient's students and staff to learn and develop skills in the various areas of cultural resource management in NPS programs and to become familiar with the administration and management of regional resource preservation programs, supporting the furtherance of mutual objectives to inform and educate Americans of the importance of historic preservation.
  - h. Provide a NPS Technical Representative who will serve as the liaison for this cooperative agreement between the NPS [representing all of the NPS parties listed in this Agreement] and the Recipient. The NPS's Technical Representative or designee, however, is not authorized to change any terms and conditions of this Cooperative Agreement unless such changes are requested with the concurrence of the key officials listed in this Agreement.

A grant agreement is proposed, therefore no substantial involvement on part of the NPS is anticipated
for the successful completion of the statement of work. It is anticipated that involvement will be limited to
actions related to monitoring project performance and technical assistance at the request of the recipient.
