I look forward to welcoming the Paterson Great Falls National Historical Park as a brand new area of the National Park Service. There are almost 400 national parks in the United States and each one celebrates a special place, person or event in American history. In Paterson, the Great Falls of the Passaic River and the surrounding historic buildings and raceways are the foundation for stories of Alexander Hamilton, the Industrial Revolution, the labor movement and the important contributions of immigrants to the making of America.

A first step in creating a common vision will be the park's first General Management Plan (GMP).

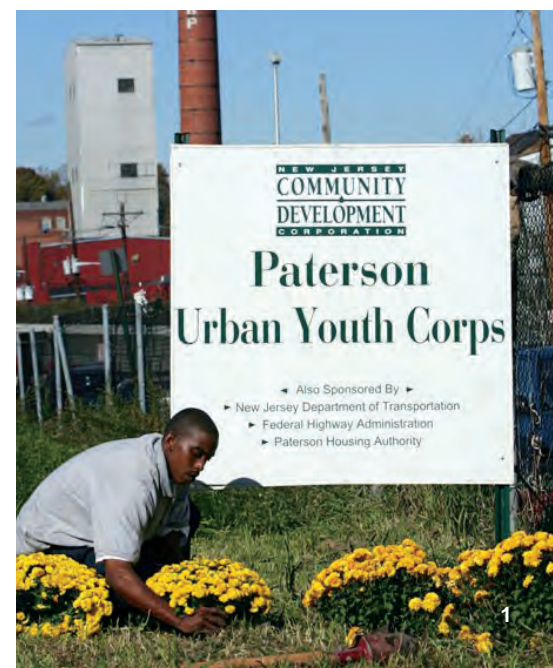

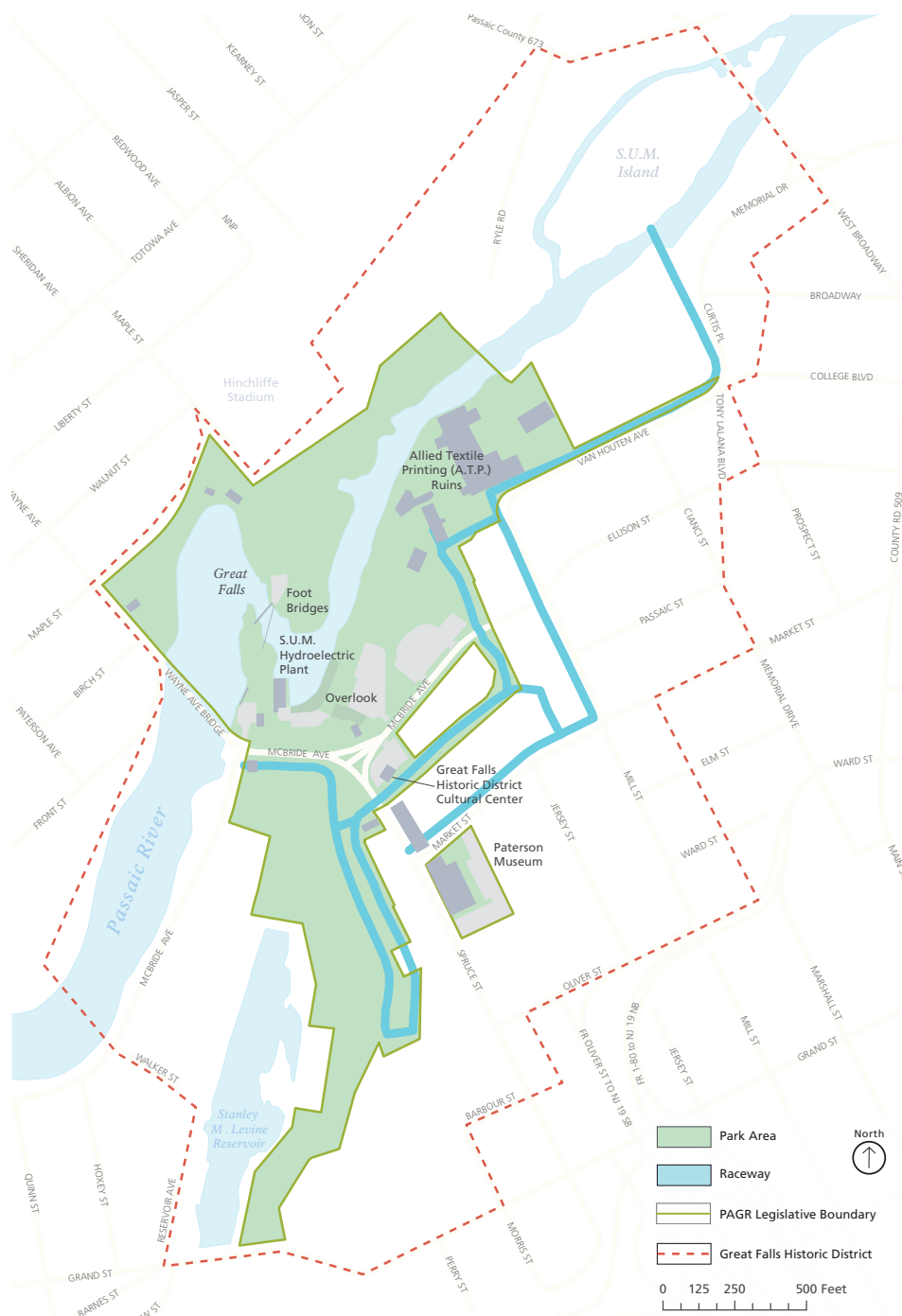


# A Brand New National Park

Since 1916, the American people have entrusted the National Park Service with the care of their national parks. National parks are here for everyone and the diversity in the national park system reflects the diversity of who we are as a nation. In places like Paterson, visitors will find experiences that bring enjoyment, inspiration and a sense of connection through interaction with the natural and historical landscapes, and the associated stories and meanings relevant to our lives today.

In 2009, Congress authorized the Secretary of Interior to establish a new National Historical Park at the Great Falls of Paterson, New Jersey for the purpose of preserving and interpreting for the benefit of present and future generations certain historical, cultural and natural resources associated with the Historic District. This designation set in motion a series of events to establish this new unit of the national park system.

The congressional legislation authorizing the establishment of Paterson Great Falls National Historical Park also provided for the establishment of a Federal Advisory Commission, composed of nine persons nominated by the Governor of New Jersey, the Passaic County Freeholder Board and the City of Paterson. This Commission is charged with advising the National Park Service and other key agencies in creating the park's General Management Plan.





# A Proud Heritage

Paterson enjoys a distinguished history as one of this nation's earliest industrial centers. It owes its existence to the far-reaching vision of one of America's most important founders, and a shaper of our modern governmental and financial institutions, Alexander Hamilton.

Hamilton envisioned Paterson, with its water power provided by the Great Falls of the Passaic River, as America's counterpart and response to the industrial revolution occurring in England during the same period. Indeed, Hamilton was not beyond attracting, through inducements and active recruitment, the talents of those who knew of the English technological advancements despite English laws prohibiting exportation of such proprietary knowledge and skilled labor.

The history of the City of Paterson includes its beginnings as the ambitious project of Hamilton and the Society for Establishing Useful Manufactures (S.U.M.) in 1792 at the Great Falls, the early development of water power systems for industrial use, and the various types of manufacturing that occurred in the District's mills into the 20th Century. These included cotton fabrics; railroad locomotives; textile machinery; jute; and silk spinning, weaving and dyeing, among many others. The Great Falls also represents compelling stories of the lives of immigrants who labored in the mills, those who owned and operated manufacturing concerns and became wealthy, and the quest of laborers and the labor movement for better working conditions and pay. Immigrants still settle today in Paterson to pursue their versions of Hamilton's vision, creating a diverse and vibrant culture.





# Looking to the Future: Creating a GMP



Picture yourself standing at the Great Falls overlook today. What do see, feel and experience? Now imagine what this place will look like 20 years from now. What changes in your view?

These questions about the future of Paterson Great Falls National Historical Park are being explored right now and we invite you to be part of creating that vision as we start the General Management Plan (GMP). A GMP lays out a vision and guides decision making to get there over the next 20 years. All units of the national park system are required to have a GMP that addresses resource protection, visitor use, facilities and boundary.

General management planning offers an open, structured decision making process that encourages and considers ideas and comments from many different people and groups. One of the goals for this GMP is to create, build and nurture long-lasting relation-

ships among those organizations, agencies and individuals interested in the park and its future.

Your ideas, expectations and concerns about the future of the park are important to us and will be carefully considered in decision making. In order to create the best possible future, these ideas and comments are matched with scholarly and scientific information and analysis.

The GMP must also comply with the National Environmental Policy Act (NEPA). This means that impacts to the social, cultural and natural environments in the park and surrounding areas will be taken into consideration.

All of the ideas, options and impacts for the future of the park are presented in a written document that will be available for you to read and make comments on. After all comments are received and considered, together, we will choose the best future for the park. A summary of the planning process, timeframe and ways for you to participate are provided on the following chart.

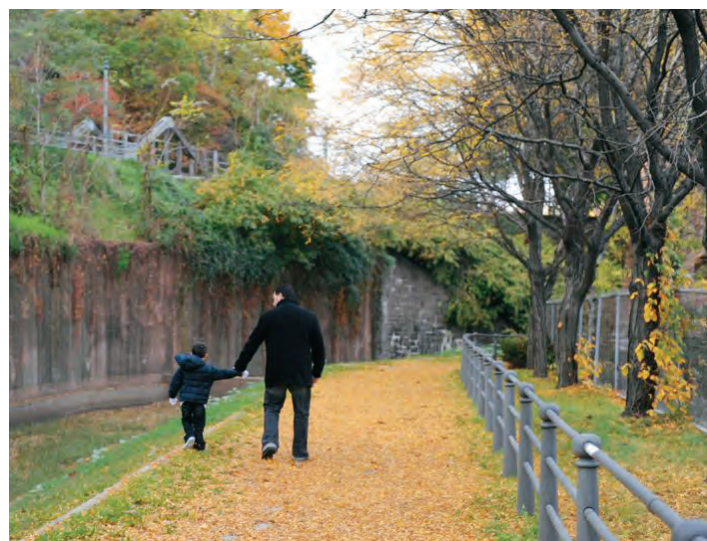

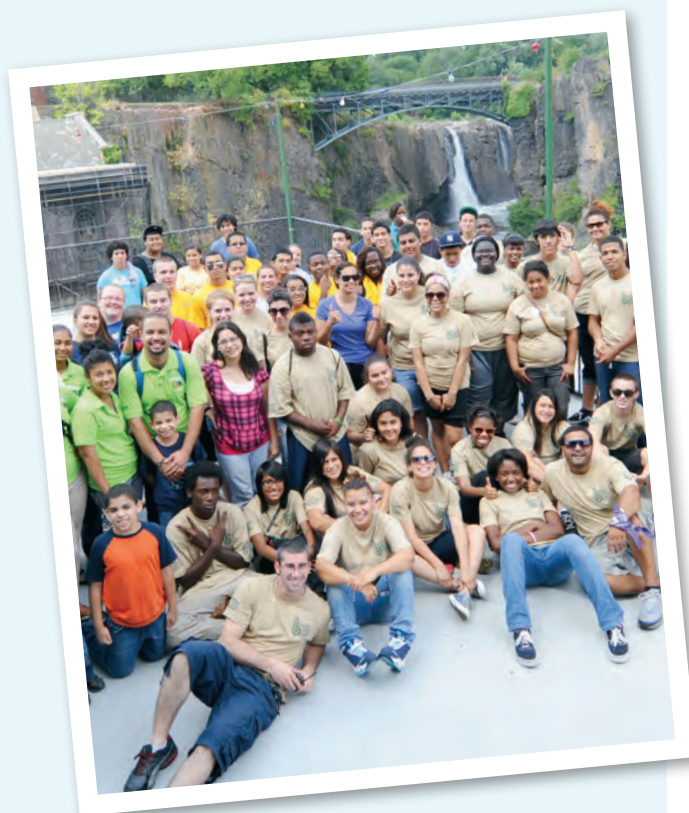
What is most special to you about the Great Falls and surrounding historic buildings?

How should NPS and other partners best protect and preserve this special place?

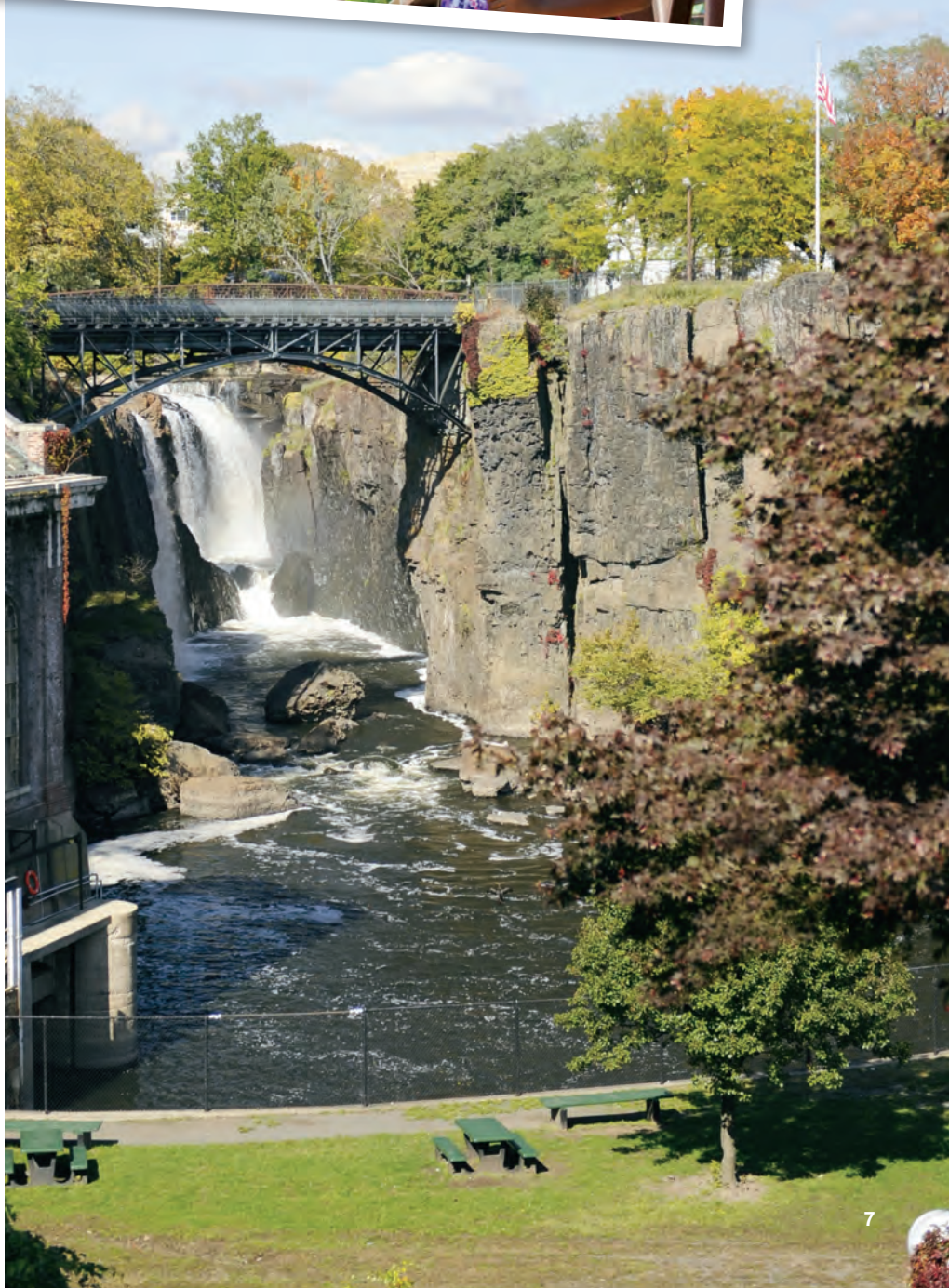
