

The ideas in the draft concept plan drew heavily from key points made by participants in a series of focus groups in March. Would you kindly take some time in advance of Tuesday to read through the draft? As you read, would you think about the following questions?

- What do you like about the draft plan? How can it be improved?
- How will we know we've been successful in making the trail more visible and real for visitors?
- What actions could you take over the next year to advance the concepts outlined for the trail?
- How can the National Park Service, the James River Association and the Commonwealth help coordinate and support these efforts?

On behalf of the planning team partners, I look forward to seeing you on Tuesday. We are anticipating good attendance from a diverse group of people and an interesting and lively discussion. Thanks again for joining us and for taking time to read through these materials!
