This project will upgrade six hardsided tent cabins in Tuolumne Meadows; units 3306, 3056, 3066, 3067 and 3089 at Bug Camp and unit 3305 at Ranger Camp.

Additional roof supports will be constructed and a metal roof will be installed. Side walls will be insulated to reduce heat loss. These upgrades will preclude the need to put up and take down these cabins each year.
