## Reviewer Guide Wilderness Stewardship Plan Preliminary Draft Alternatives

The National Park Service (NPS) is preparing a Wilderness Stewardship Plan and Environmental Impact Statement (WSP) for Sequoia and Kings Canyon National Parks. Last spring and summer, we received more than 900 comments during the initial public scoping period for the WSP. We reviewed all of the comments and have identified topics which will be addressed in the WSP. For each of the key topics, we have developed preliminary draft alternatives.

On this website you will find materials available for your review including detailed descriptions of the preliminary draft alternatives. The descriptions of the alternatives have been separated into the following tables:

- 1) Zones and Permitting/Quotas
- 2) Trails, Bridges, and Signs
- 3) Campfires, Food Storage, and Human Waste
- 4) Party Size: People and Stock
- 5) Camping: Campsites, Stock Camps, and Camping Night Limits
- 6) Stock Use: Access and Travel; Camps; Party Size; and Grazing
- 7) Administrative Facilities: Ranger Stations and Crew Support Facilities
- 8) Other Facilities: Redwood Canyon, Pear Lake, Bearpaw Meadow High Sierra Camp, and Frontcountry Facilities

We are asking for your input. Please carefully review the tables and provide us with your thoughts. Have we identified a sufficient range of alternatives? Have we missed any key topics? What do you like about the alternatives? Are there specific elements that should be changed, and how would you change them? We will use these comments to help us further refine the alternatives. The refined alternatives will be presented in the Draft WSP which will be available for public review in late 2013.
