

Extension of Paseo del Morro

Dear Friends,

The National Park Service (NPS) and the Municipality of San Juan, in compliance with the National Environmental Policy Act of 1969, plan to prepare an Environmental Impact Statement (EIS) to evaluate options and potential impacts of extending the Paseo del Morro National Recreational Trail from its current end at Castillo San Felipe del Morro to the Lomita de los Vientos area, near Fort El Abanico at Castillo San Cristóbal. The extension of the Paseo will involve construction on areas that are not within the boundaries of the San Juan NHS and under the jurisdiction of the Commonwealth of Puerto Rico and the Municipality of San Juan. The park and the Municipality, with the assistance of the Rivers, Trails and Conservation Assistance Program (RTCA), have already conducted meetings with the residents of La Perla and other interested parties to insure that their needs are considered as we evaluate the potential effects of the extension of the Paseo through the La Perla community

The extension of the Paseo del Morro National Recreational Trail was first proposed by the National Park Service as part of the mitigation measures taken as a result of the Morris Berman Oil Spill Restoration Plan and Environmental Assessment completed in 2006. This restoration plan contemplated the extension of the recreational trail in seven phases of which two, based on the findings of the Environmental Assessment, are already completed. The next phases are covered within the scope of this Environmental Impact Statement and is the reason why the NPS and the Municipality are seeking your involvement and participation.

The purpose of this newsletter is to provide you with information about the project and related issues and to ask for your help. This project is important for the creation of recreational, educational and access opportunities to the 1.5 million visitors who visit San Juan National Historic Site, Old San Juan as well as the neighboring communities. The project is important to the future of the park and the old city. That is why we are seeking your input on the proposed project and the alternatives and issues to be included in the environmental impact statement. Please plan to attend public meetings on February 5, 2013 on the Community Center at the La Perla Community Center, and on February 6, 2013 at San Juan NHS Headquarters on Castillo San Cristóbal. You will have the opportunity to speak with the staff from the Municipality and the park, ask questions, and comment on this project. Project Purpose, Background and Scope

Project Purpose and Background

The existing Paseo del Morro is a National Recreational Trail located in San Juan National Historic Site at the northwestern tip of the Old San Juan Islet. It provides a waterfront route that connects important areas such as Paseo La Princesa and Puerta de San Juan. The proposed action consists of the extension of the existing Paseo from its current terminus point at the Floating Battery area to the San Juan Bautista Plaza located in front of the state Capitol.

In 1981, the US Army Corps of Engineers (ACOE) installed a breakwater shoreline revetment to protect the historic fortifications from erosion and damage caused by the constant impact of the sea. In 1999, the tourism office proposed to the NPS and the State Historic Preservation Office (SHPO), a project to rehabilitate the shoreline and a rudimentary shoreline trail already in existence. In 2006, the NPS and the Commonwealth of Puerto Rico, in compliance of the National Environmental Policy Act (NEPA) and the Oil Pollution Act, prepared a Restoration Plan and Environmental Assessment to address restoration of the natural, ecological and recreational damage caused by the T/B Morris J. Berman grounding and oil spill off the coast of San Juan, Puerto Rico, on January 7, 1994. The preferred alternative in this Environmental Assessment was the extension of Paseo del Morro National Recreational Trail in seven phases.

The NPS, the Municipality of San Juan and the Commonwealth propose to extend the Paseo del Morro over several jurisdictions to provide access to the northwest coast of the Old San Juan Islet, to create recreational public space along the corridor, protect the historic walls of Castillo San Felipe del Morro and the Santa maría Magdalena de Pazzis Cemetery, and encourage visitation and tourism within the area of potential effect which include the La Perla neighborhood. The possible impacts of the project and reasonable alternatives for it need to be analyzed and assessed in an Environmental Impact Statement (EIS).

Proposed Action and Alternatives

The environmental impact statement will evaluate the possible environmental effects of the proposed extension of the paseo as well as other reasonable alternatives. A range of alternatives will be considered, including a no-action alternative. At the conclusion of the process the National Park Service, the Municipality of San Juan, and the Commonwealth of Puerto Rico will make a decision

regarding the possible extension of the paseo.

Scope

This study will consider impacts on cultural and natural resources, including potential archeological sites, geologic resources, vegetation, air quality, wildlife, special status species, etc. It will also consider impacts on visitor use and experience, socioeconomic environment and, transportation.

While the Municipality of San Juan is sponsoring the study, the National Park Service is the lead on this federal action. As the lead agency, the National Park Service will have decision authority over implementation. This project will likely involve a number of agencies, jurisdictions and stakeholders at the local, state, and federal levels. To develop a realistic plan, the National Park Service will seek input from other resource and technical agencies and stakeholders, included but not limited to the following:

- Municipality of San Juan
- Environmental Quality Board
- Department of Natural and Environmental Resources
- State Historic Preservation Office
- Institute of Puerto-Rican Culture
- Army Corp of Engineers
- US Fish and Wildlife Service
- National Oceanic and Atmospheric Administration


