## **NPS Website Launched for Interim Protected Species Management Strategy**

The National Park Service has published a webpage dedicated to the upcoming Cape Hatteras National Seashore Interim Protected Species Management Strategy planning project. This webpage provides project background, planning process, and public meeting notice information; as well as links to relevant update/planning documents and websites. The Interim Protected Species Management Strategy will be the guiding document for protected species management at the Seashore until the park's Off-Road Vehicle Management Plan is completed in 2008 as currently scheduled.

The webpage is located on the *National Park Service Planning, Environment and Public Comment (PEPC)* website, http://parkplanning.nps.gov. The PEPC website provides public access to all of the currently PEPC-listed active plans and environmental documents for the National Park Service.

The Interim Strategy planning project webpage will be updated as project milestones are reached or when important public information is disseminated.

Later in the planning process, when planning documents are released for public review and comment, this site can be used by the public to submit comments on-line.

The public can also gain information about the Interim Strategy process by attending any of the information meetings and sessions scheduled for the weeks of Oct. 2<sup>nd</sup> and 9<sup>th</sup>. These meetings and sessions will help maximize public involvement in the development of the Interim Protected Species Management Strategy.

Formal-style public Information Meetings are scheduled for: Monday, Oct. 3<sup>rd</sup> at the Wright Brothers National Memorial First Flight Centennial Pavilion, Kill Devil Hills; Tuesday, Oct. 4<sup>th</sup> at the Dare County Fessenden Center, Buxton; and Wednesday, Oct 5<sup>th</sup> at the Ocracoke Community Center. Each meeting will begin at 7:00 pm and last until 9:00 p.m.

Open house-style, information sessions are also scheduled for Oct. 5<sup>th</sup> 12p.m.-2 p.m. at the Rodanthe/Waves/Salvo Community Building, Rodanthe; Oct. 6<sup>th</sup> 12 p.m.-2 p.m. at the Wright Brothers National Memorial First Flight Centennial Pavilion; Oct. 6<sup>th</sup> 4 p.m.-6 p.m. at the Graveyard of the Atlantic Museum, Hatteras Village; Oct. 11<sup>th</sup> 4 p.m.-6 p.m. at the National Park Service

Ocracoke Maintenance Building. These Information Sessions will allow people to talk with park managers in a more informal setting.

"We want to hear from everyone that has an interest in the park use and species protection" stated Patrick Reed, Outer Banks Group Acting Superintendent. "We place a high value on working together in partnerships with our communities to make sure we balance the National Park Service responsibilities with their needs." We need to hear from everyone we can so that we can shape this interim management strategy to provide the greatest continued public use and access possible, while at the same time meeting the requirements of law designed to protect the resources that contribute to making Cape Hatteras National Seashore the very special place it is."
