Comment Summary

The English Camp trails open house began with a map and comment exercise that asked participants to identify where they accessed the English Camp trails.

Most participants (6) identified the Horse Trail Road entrance to Mitchell Hill. Other participants identified; 5 identified the junction of West Valley Road and Westcott Bay Drive; 4 identified the English Camp parking area; 2 identified the northwest corner of Mitchell Hill; 1 identified the south central boundary of English Camp (adjacent to private land); 1 identified the parking area at Westcott Bay; 1 identified an interior area in Mitchell Hill; 1 identified a north Roche Harbor Highlands/Mitchell Hill boundary access point; and 1 identified a south Roche Harbor Highlands/Mitchell Hill access point.

EM5c) Provide just a few entrance only signs on multi-use trails as follow:

- Lake Trail; from the triangle trail intersection over the turnpike and on to Briggs Lake.
- Mitchell Hill Trail; from the same intersection and up over Mitchell Hill to the logging road.
- Alder Trail; from the logging road up through the Alder Woods to connect with the logging trail behind Mitchell Hill.
- The main logging road which passes from Mitchell Hill past the Horse Trail Gate to around the back of Mitchell Hill.
- Young Hill Trail up the back of Young Hill

PM10) Put more information on the map so there are fewer signs on the ground.

PM12) There are quite a few trails that criss-cross the main road loop that are not shown on the map.

PM13) Trails are hard to identify -- no names.

PM14) Destinations are an important trail use component -- trail users are usually headed somewhere.

EM5i) [Install] a hitching post on the Young Hill trail where the horses are asked to stop near the top, so that riders are able to take in the wonderful view of the islands.
EM5j) [Locate] a hitching post at the end of the trail in English Camp, and maybe a picnic table nearby.
PM1) Put infrastructure into trails rather than facilities -- don't overbuild
PM48) Add hitching posts to Mount Young so that riders can get off and hike to the top.

T4o) Add hitching posts where horses can't go, such as on Young Hill

PM21) Identify the trails that tourists are likely to use/be directed to for improvement.

Establish new trails (12 comments)

Provide horse access to Westcott Bay (1 comment)

EM12a) It is extremely exciting to hear we may get a loop for horses on the new Westcott bay property (bought property because of horse trail access)

Establish new access to Horse Trail Road (5 comments)

EM9a/b) interested in . . . another multi-use entrance near the top of Yacht Haven and West Valley. Several of us ride out of the Blazing Tree Equestrian Center and accessing the Horse Trail gate via the easement along West Valley next to the white fencing can be treacherous during the winter. The trail narrows considerable as it approaches Horse Trail, is very wet and muddy, and some of it is partially submerged at times.

EM5l) [Allow] multi-use on the existing trail or another multi-use trail entrance near the top of Yacht Haven and West Valley to take some of the pressure off Horse Trail Gate entrance.

EM14a) There are a number of equestrians that access the National Park trails from the Blazing Tree area. Currently we use the easement along West Valley Rd. in front of the white fencing of Twin Oaks to get to the Horse Trail gate. During much of the year due to our wet weather that trail is very slippery and muddy, and part of it is completely submerged under water. That easement trail is extremely narrow as it gets to the corner of the white fencing and Horse Trail and potentially could be very dangerous if a horse took a misstep.

EM14b) Is there a possibility that a new trail into the National Park could be created somewhere around Yacht Haven and West Valley Rd.? The easement we would have to ride in that direction is much wider without the steep drop off to the drainage ditch along West Valley Rd.

EM15b) re: Yacht Haven/West Valley Road horse trail (EM14b): Your idea would take some of the pressure off the very popular Horse Trail Rd entrance to the San Juan National Park.

Establish Access via the Sandwith Orchard Trail (1 comment)

EM15a) I have been asking for quite a while for a trail leading up through the orchard or along the NPS border with the private property on the south end of English Camp leading over to the Lake Trail which leads to Briggs Lake and all the trails. In the past, NPS Superintendents have not been interested. But at the recent NPS meeting Lee Taylor announced she was looking at this idea favorably.

Create new multiuse trail to link English Camp properties (3 comments)

PM46) Link English Camp properties with a multiuse loop trail.

T4c) Create a new trail connecting all three sites English Camp, Westcott to Mitchell Hill -- multiple use

EM5m) [Establish] a possible multi-use loop trail going from Mitchell Hill area to English Camp

Other (2 comments)

T2b) Establish new trail from Roche Harbor/West Valley intersection to English Camp

EMf) . . . now we need a trail leading from the parade ground area to the intersection of West Valley Road and Roche Harbor Road; it could follow the 100' contour line.

Retain the following trails (3 comments)

EM5d) The following are necessary connector trails:

- Kneeknocker Trail from the Logging Rd around Briggs Lake, on both sides of Mitchell Hill trail, around the back of the top of Mitchell Hill and then joining Mitchell Hill trail.
- Lars Trail heading uphill from the first puncheon on Kneeknocker winding up through the woods and over to Mitchell Hill trail near the top.
- The trail just south of Horsetrail Gate Rd heads east up into the woods and intersects with the Alder trail just before connecting with the logging road.
- The main trail headed south from the Alder Trail, through the woods south coming out on the logging road near the trail to the Boy Scout Camp.

EM4d) There are two delightful trails at Mitchell Hill that are not on the map and I believe should be. One is just after turning left (north) at the entrance Y; it crosses a little seasonal brook with a dilapidated bridge into a cathedral-like area, and rejoins the main trail farther north

EM4e) [Trail not on map] The other is almost immediately after turning right at the entrance Y, and I believe was created by the bicyclists; it is breathtakingly beautiful with green, green moss and intermittent sunlight coming through the trees. It's fairly steep, and I prefer to walk up it, rather than down, but it connects to a wide logging-road trail that will bring you back to the entrance.

Limit use in sensitive areas (16 comments)

EM3a) close off the sensitive areas from horses & bikes. . .

EM4c) narrow north-south trail through the middle of the Mitchell Hill property be closed to horses and bikes during the wet months, unless it can be improved so that the water drains off.

PM3) Could consider limiting mountain biking/horseback riding where trails are wet or mossy for both user groups or where extremely steep for horseback riding

PM4) No mountain biking in cedar grove

PM5) No horseback riding in cedar grove

PM22) Minimize or avoid horse and mountain bike use where it is steep, mossy or wet.

PM23) Balance recreation with resource protection.

PM24) Protect fragile areas.

PM28) Wet areas could have limited access.

PM29) The park should not be married to maintaining trails in existing locations -- there may be a less sensitive location/rerouting that could be done.

PM30) Avoid multiuse in riparian areas.

PM31) Consider seasonal closures if necessary to horses and bikes during wet season.

PM36) Evaluate trail, determine uses desired to provide and if the trail does not meet this, either rebuild or reroute.

T4g) Protect spring fed riparian area

T4h) Steep, mossy, wet areas should not be for multiple use

T4i) Limit seasonal hiking based on sensitivity

Some user groups have greater impacts on trails (4 comments)

EM3b) horses & bikes-weight and speed have a much bigger impact on trail, especially riparian areas. . .

EM3f) bikes & horses are hardest on wet areas, switchbacks/climbing turns, and tree roots/sensitive vegetation

PM54) Avoid use by BMXers, freeriders, because they create jumps

T3c) while biking on some trails should be appropriate, specific mountain bike trails with bike specific trail designs is not appropriate

User conflicts may occur with increased use (4 comments)

PM7) Multiuse could be problematic if there is increased use.

PM20) Limit multiuse/trail use based on carrying capacity -- with more publicity of the site, develop parking, there may be increased overall use and thus more conflicts.

T4f) Low level overall use/rarely see other groups

PM39) Use has increased since NPS took possession. There are more people putting more pressure on resources.

Minimize conflicts by separating equestrians and bicyclists (1 comment)

EM3c) split up your horses and bikes just to be safe-speed of bikes & horses spooking on a blind corner or high veg area not so good, even if you have a good yielding system. . .

Minimize conflicts by creating one-way trails (1 comment)

EM3h) one direction flow is very helpful to decrease collision [for mountain bikes]

Design specific trails for equestrians and bicyclists (5 comments)

EM3d) bike & horse trails should be designed for that from the get go-they use trail very differently,

EM3g) good mountain bike trails need banked corners, lots of mileage, fortified corners/switchbacks, tree root coverage, speed checks & gains, trick/play spots (if you build them, they will come),

EM3k) good horse trails need to fortify corners/switchbacks, manage water/tread & drainage well, hold their weight w/ bridges/turnpikes/puncheons, have a solid & wide bench on sidehill trails to keep the outer bench from eroding, have good visibility

PM37) It is better to recreate or reconfigure a trail to accommodate preferred uses.

PM47) Build trails for appropriate use (horse, hiker, multiuse trails have/should have different characteristics)

Keep horses and bicyclists off hiking trails using fencing (1 comment)

EM3i) [Use] the "z" style fence that keeps out horses & bikes

Establish loop trails (3 comments)

EM3j) designing overall trail to be one big loop between all the properties,

EM3i) w/ smaller loops/or connecting trails in the middle makes it a 'smarter' trail system where folks can pick appropriate mileages for what they want, bikes and horses are 'satisfied' w/ longer trip abilities, hikers can explore different loops, folks can exit at various access points, and loops keep it interesting so hikers aren't always going in and out on the same trail

EM3l) [M]ap out an overall system/loop series that connects properties, closes/opens certain areas (sensitive, high impact, unique features, historical info, views) before deciding which trails for what user in addition to public input

PM19) Many trail loops are possible (loop trails desirable).

Design trails for ease of maintenance (1 comment)

EM3m) . . . consider the ease w/ which trail maintenance can be done in those marked places-do we need a turnpike? if so, do we have any nearby borrow pits (mineral soil to mine), if not, we're transporting in material for fill-might be impossible or really difficult, so next option....re-route? might be easier considering location....

Determine what impacts are occurring (4 comments)

PM25) Are there sensitive resources at Mitchell Hill? Can we limit use to protect those?

PM26) Are resources currently being damaged?

PM32) What is the impact of trail use on resources?

PM33) What is the impact of trail use on users?

Horses cause impacts (2 comments)

PM34) Walk and poop vs. stop and poop

PM35) Clean up after horses

The trail system is confusing/safety issues (4 comments)

PM41) People get turned around and confuse Roche Harbor Road and West Valley Road.

PM40) Since NPS took possession, motorcycle, ATV and hunting/trapping have decreased.
