



Project Background

Moccasin Bend is a prominent bend in the Tennessee River just northwest of downtown Chattanooga. On the bend is the best preserved and most important compact, diverse sample of archeological remains known in the entire 650-mile Tennessee River Valley. The area contains a special collection of sites that chronicle important aspects of human history from almost 10,000 years of continuous occupation on the North American continent including: 1) transitional Paleo-Archaic and Archaic sites, 2) woodland period settlement sites, 3) fortified protohistoric villages, 4) an area representative of Spanish exploration and settlement of the southeastern United States and a contact point between native and nonnative peoples, 5) a location along the Trail of Tears National Historic Trail, and 6) the location of Union earthworks such as cannon emplacements, rifle pits, bivouac pads, and access roads that were of strategic importance in breaking the Confederate siege of Chattanooga. The area offers the potential for historic preservation and public education that could enrich the appreciation of America's history. The quality, diversity, and broad accessibility of these archeological resources cannot be matched within any other American metropolitan area.

On Moccasin Bend is the 956-acre Moccasin Bend National Historic Landmark (NHL) that was designated in 1986 (see map for boundary details). In 2003, 755 acres on the bend were added to Chickamauga and Chattanooga National Military Park (park) as the Moccasin Bend National Archeological District (unit) of the park. These 755 acres are the focus of this Development Concept Plan/Environmental Assessment (DCP/EA) for a proposed interpretive/cultural center.

There are varied land uses on Moccasin Bend including government facilities and residential, recreational, and industrial development. There are five major categories of land ownership: the National Park Service (755 acres), the City of Chattanooga (184 acres), the City of Chattanooga and Hamilton County (183 acres), the State of Tennessee (102 acres) and private property (22 acres). On the northern-most area of the bend is a 99acre tract of National Park Service (NPS) land that was previously owned by the Rock-Tenn Company. At that tract's southern boundary is the City of Chattanoogaowned Moccasin Bend Wastewater Treatment Facility.



Near the junction of Hamm Road and Moccasin Bend Road there is a small residential area, a City of Chattanooga and Hamilton County tract, and an NPS tract (often referred to as the Serodino property). The City of Chattanooga and Hamilton County jointly own the Moccasin Bend Golf Course, the Law Enforcement Firearms Training Range, and the former model airplane facility. Private ownership accounts for 22 acres including the WDEF radio towers and a private residence. The state-owned mental health hospital occupies 102 acres on the southern portion of the bend. Traversing the bend are two Colonial Pipeline 50-foot petroleum pipeline rights-of-way and a Chattanooga Electric Power Board 150-foot high tension power line right-of-way. Interspersed amongst these various properties and interests are NPS tracts, one of which includes the Blue Blazes Trail between the golf course and the WDEF radio towers. The National Park Service also owns shoreline easements along the waste water treatment facility, golf course, mental health hospital, and firearms training range.

Significant Milestones

1950 — Congress first enacted legislation which authorized the addition of up to 1,400 acres of Moccasin Bend to Chickamauga and Chattanooga National Military Park.
Property was acquired by state, county, and city governments but never trans- ferred to the National Park Service.
1984 — Moccasin Bend was listed on the National Register of Historic Places.
1986 — A 956-acre area was designated as the Moccasin Bend National Historic Landmark.
1999 — A special resources study and environ- mental assessment was completed for the site and transmitted to Congress.
2003 — The 755-acre Moccasin Bend National Archeological District was added to Chickamauga and Chattanooga National Military Park as part of the Consolidated
Appropriation resolution (Public Law 108-7). This law also authorized the Secretary of the Interior to develop an
interpretive/cultural center for the site. 2005 — The National Park Service begins work on a Development Concept Plan/ Environmental Assessment for the Moccasin Bend unit of Chickamauga and Chattanooga National Military Park.

Project Purpose

The purpose of the Moccasin Bend National Archeological District, Development Concept Plan/Environmental Assessment is to:

Establish the management direction for the Moccasin Bend unit including guidance on resource protection and visitor use. Determine the location and development needs for the Moccasin Bend interpretive/cultural center. Analyze an appropriate range of alternatives and involve federally affiliated tribes, partners, agencies, and the public in the project through the environmental assessment process.

Primary Tasks

- 1. Identify the purpose, significance, legislative mandates, and fundamental resources associated with the site.
- **2.** Determine the primary interpretive themes for Moccasin Bend.
- **3.** Develop alternative concepts for the design and location of the interpretive/cultural center.
- 4. Analyze transportation and access issues for Moccasin Bend.

- **5.** Conduct *Level 1* archeological surveys of each site considered for the interpretive/cultural center.
- 6. Develop initial capital and annual operating costs for each alternative concept for the interpretive/cultural center.
- 7. Complete environmental analysis of the alternative concepts.
- 8. Provide guidance on the scope of collections.
- **9.** Provide guidance on future commercial services.
- **10.** Select a preferred alternative for the facility programming and location of the interpretive/cultural center.
- 11. Publish the DCP/EA.

The Planning Process and Where We Are

Consultation with the federally affiliated tribes on the Moccasin Bend DCP/EA began on September 20 and 21, 2005. On September 22, 2005 the planning team initiated consultation with other stakeholders and partners at a midday public open house in the Chattanooga Theater Lobby at Coolidge Park and an evening public meeting at the Tennessee Aquarium.

We heard a range of comments on: 1) what the focus, scale, and type of development should be on the site, 2) concerns about the future development of the site, and 3) recommendations on how the project should precede. Project Givens

- The planning project will take approximately two years.
- Congress will not likely authorize the National Park Service to spend more than \$5.0 million on the interpretive/cultural center.
- The National Park Service will work closely with the non-profit Friends of Moccasin Bend National Park organization and other partners to explore the scope of the interpretive/cultural center and potential funding options above the \$5.0 million authorized by Congress.
- There will be extensive involvement with the federally affiliated tribes, the public, and other interested parties.

Other Related Projects

Bank Stabilization Project for Moccasin Bend National Archeological District, performed by U.S. Army Corps of Engineers for the National Park Service

> Riverbank erosion threatens the valuable cultural resources on Moccasin Bend that chronicle almost 10,000 years of human history including Native American occupation and Civil War sites. The US Army Corps of Engineers (USACE) is in the process of developing bank stabilization design alternatives for almost six linear miles of riverbank along the Tennessee River around the bend. The alternatives range from stonefill designs to soil-fill designs incorporating native plant species.

General Management Plan/Environmental Impact Statement for Chickamauga and Chattanooga National Military Park, National Park Service

The General Management Plan (GMP) for Chickamauga and Chattanooga National Military Park is 17 years old and inadequate to address the policy and operational issues now facing the park. A new GMP is required due to significant changes at the park including the addition of the Moccasin Bend unit and the relocation of US Highway 27 around the Chickamauga Battlefield. Although the GMP planning effort is separate from the Moccasin Bend DCP/EA, the two projects will be closely coordinated. The GMP effort will begin later this year.

North Shore Plan, Chattanooga-Hamilton County Regional Planning Agency

The North Shore Plan will expand the boundaries from the previous plan adopted in 1992 to reflect current growth issues. It will examine the built environment, transportation, public spaces, and natural systems, and primary commercial corridors within the district. The interface between the commercial corridors surrounding residential areas as well as connections to Moccasin Bend will be considered.
