



## Muir Woods Transportation Enhancement Highlights

### **Comprehensive draft agreement reached between the County of Marin and National Park Service**

- Memorandum of Understanding drafted with input from public meetings, community representatives and stakeholders

### **Visitation experience will be improved and visitation levels limited**

- To increase the quality of the visitor experience and in a way that reduces peak congestion and overall demand for parking (*see attached visitation charts*)
- Provides different experiences, accommodating busy summer weekends while ensuring quieter off season periods

### **Public Transit serving Muir Woods will be increased**

- Ongoing commitment to proven Muir Woods shuttle

### **Commercial buses arrival will be managed and controlled**

- Bus sizes will be limited to 35 feet
- Arrival will be via reservation only

### **Parking enforcement capability will be upgraded**

- National Park Service given authority to issue tickets along road, additional dedicated enforcement officers
- Physical barriers and new signage for unsafe parking will be installed to reduce peak roadside parking from 400+ to 110 spaces, with further reductions over time

### **Creekside parking along the road eliminated**

- Road shoulder parking along Muir Woods Road south of the concrete bridge that is closest to the creek will be completely eliminated over a number of years through a phased ramp down (*see attached map*)

### **Watershed health improved**

- Reduced shoulder parking and fewer vehicles near to creek
- Interim storm water management measures will be implemented in roadside parking areas
- Continued collaboration on habitat improvement projects along Redwood Creek

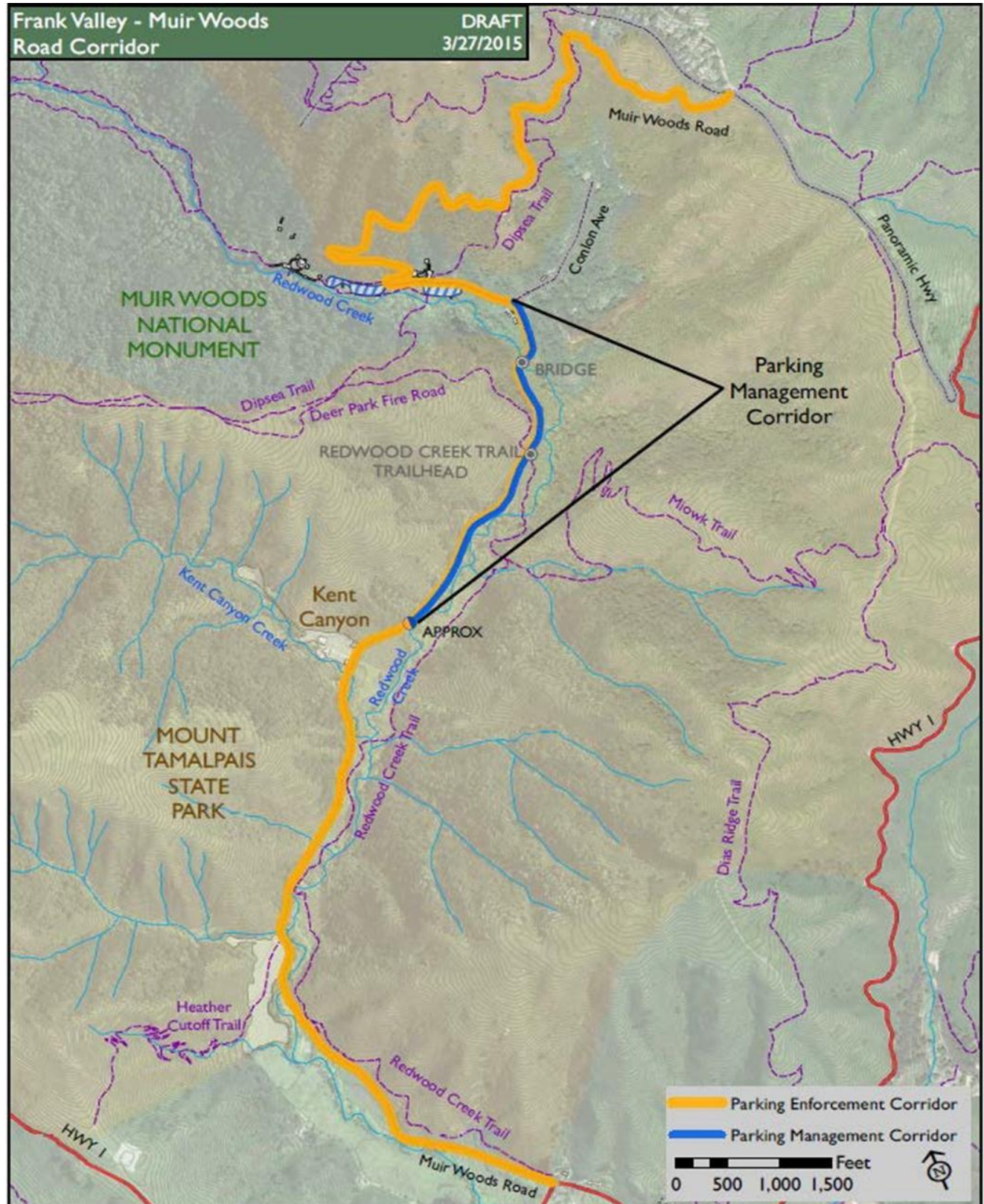
Reservation System Launch



## Parking Management Map for Muir Woods Road

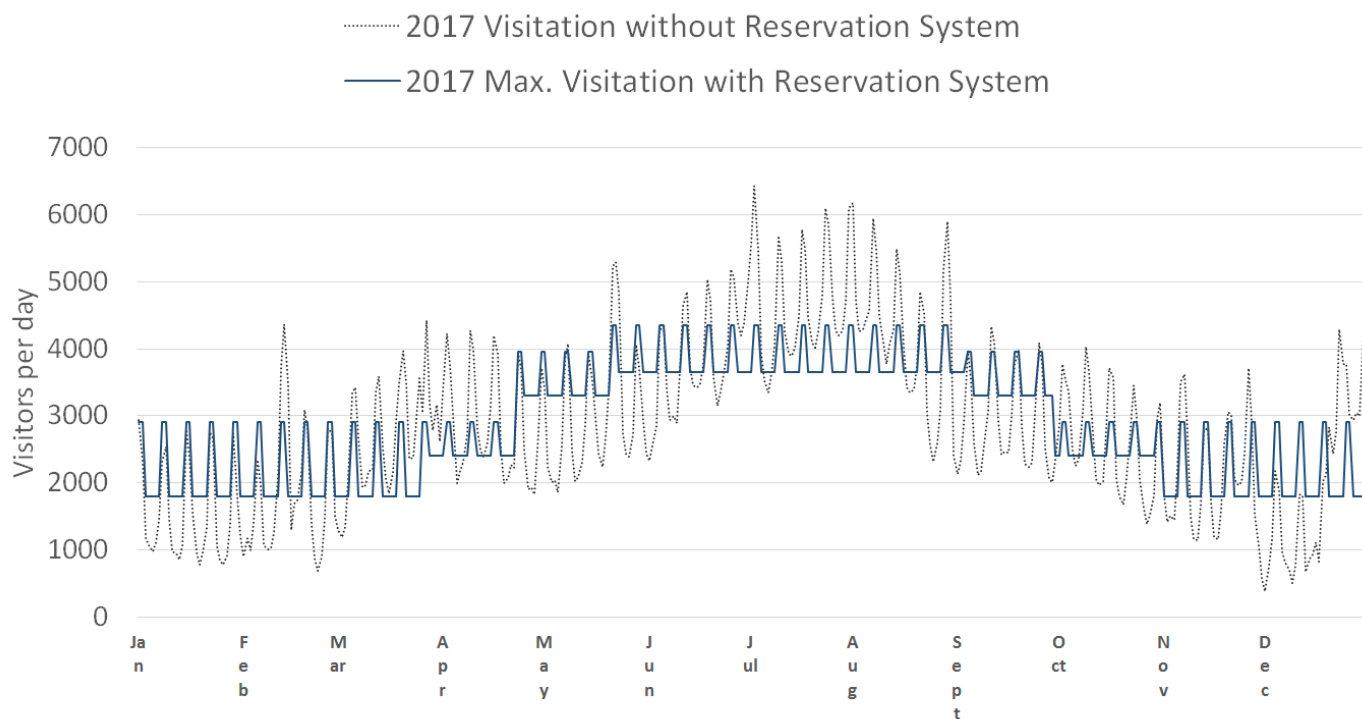
The **Parking Management Corridor** is where parking will be permitted and reserved for peak periods. A maximum of 80 cars will be reserved and permitted south of the the dot marked "BRIDGE". Over time all parking south of the "BRIDGE" will be removed.

The **Parking Enforcement Corridor** is where NPS and Marin County Sheriff will have enhanced parking enforcement.



## Projected Visitation Charts for Muir Woods

Under the NPS reservation system, visitation will be limited during peak hours and days. The below chart shows what daily visitation is estimated to be in 2017 (black dotted line) without a reservation system and the blue line would be the maximum visitation once the reservation system is implemented. In peak periods, daily estimated vehicle trips to Muir Woods would be reduced by 20-30%, and in peak hours, vehicle trips would be reduced by approximately 40-50%.



Public access to Muir Woods would remain with more intentional management. Under the reservation system, different visitation levels will occur at different times in the year. Over 50% of the year, visitation would be less than 3000 visitors per day, and around 30% of the year, visitation would be less than 2000 visitors per day. Peak periods (summer weekends) will accommodate high visitation but will be limited to under 4500 per day (down from current peak days of 5000-6500) with managed hourly arrivals to reduce congestion and to prevent the Woods and its parking from being overwhelmed.
