Project Description

Note: Review Per Lead Project extends from near Muir Woods national Monument to Hwy 1. Improvements to Redwood Creek Trail in Mt. Tamalpais State Park and Golden Gate National Recreation Area include: reconstructing 0.28 miles of trail,; developing 1.1 mile of new trail outside of the creek floodplain and decommissioning a corresponding 0.9 mile of existing trail located in the floodplain,; removing culverts and bridges on the decommissioned trail segment; eliminating creek fords and replacing them with bridges; removing culverts and crib walls on drainages to the creek that are crossed by the trail and replacing these with bridges; and repairing and rehabilitating trail tread. The work would take place during summer/fall dry seasons over a 4-year period.
