This photo shows the existing Appalachian Clubhouse and parking area. Most of the alternatives propose restoring the Clubhouse for day use.



Photo 1A: Proposed Parking Area at the Appalachian Clubhouse

This simulation demonstrates mitigation of adverse visual impacts. The technique minimizes the negative effect of the parking area by screening the views of vehicles. Proposed vegetative screens would enhance the parking area at the Appalachian Clubhouse and assist in reducing the amount of visible parking area. Transplanted evergreen vegetation would provide year round screening. Pervious concrete would allow for accessibility and reduce the potential for impacts to the environment.

The area shown consists of the Bagley (#17) cabin and the Jamerson (#14) cabin. In some alternatives, this area has been proposed as a possible site for a parking lot.



Photo 2A: Proposed Parking Area in Daisy Town

This simulation demonstrates conservation design techniques by proposing parking areas with the existing vegetation preserved. Parking lots will be placed in areas that require minimal impact to surrounding vegetation. Screening between roads and parking areas also reduces views of vehicles and pavement. Small tree seedlings from other locations in the District could be transplanted to provide additional screening.

This simulation demonstrates the effect of removal of the Vernon Moore cabin located in the Wonderland Club. This simulation depicts preservation of the rock foundation and chimney.
