The study was completed pursuant to Public Law 109-319, the Ste. Genevieve County National Historic Site Study Act of 2005, signed on October 11, 2006. The act directed the Secretary of the Interior to evaluate an area that includes the Bequette-Ribault, St. Gemme Amoureaux, and Wilhauk homes, and the related and supporting historical assets located in Ste. Genevieve County, Missouri, to see if it meets the criteria for addition to the national park system.

Section 100507 of Title 54, United States Code, establishes the criteria to be considered in the study of an area for potential inclusion in the national park system. A study area must possess nationally significant natural or cultural resources and represent one of the most important examples of a particular resource type in the country; be suitable and feasible for addition to the system; and appropriate for direct National Park Service (NPS) management.

The NPS finds that certain resources in Ste. Genevieve, including the properties listed above, meet the established criteria for inclusion in the national park system. Ste. Genevieve has long been recognized as a nationally important collection of French vertical log architecture, and a portion was designated a National Historic Landmark in 1960. In the *Ste.
