### National Capital Memorial Advisory Commission Notice of Public Meeting

A meeting of the National Capital Memorial Advisory Commission (the Commission) will be held at **1:00 p.m. on Tuesday, October 4, 2016**, in Room 311, the Boardroom of the Commission of Fine Arts at the National Building Museum, 401 F Street, N.W., Washington, D.C.

The Commission will meet to review recently introduced memorial legislation, to provide consultation on authorized memorials, and to be updated on other memorials currently in progress.

- (1) Review of H.R. 4564, to redesignate Reservation 302 as Robert Emmet Park.
- (2) Review of H.R. 5457, to redesignate Gravelly Point Park as the Nancy Reagan Memorial Park.
- (3) Review of H.R. 5684, to authorize modification or augmentation of the Second Division Memorial.
- (4) Consultation with the Gold Star Mothers National Monument Foundation on design concepts for the Gold Star Mothers Family Memorial.
- (5) Updates on memorials in progress.

The meeting will begin at 1:00 p.m. and is open to the public. The Commission members will meet in Room 311, the Boardroom of the Commission of Fine Arts which is located on the 3rd Floor of the National Building Museum, 401 F Street, N.W., Washington, D.C., 20001. The Commission was established by Public Law 99-652, the Commemorative Works Act (40 U.S.C. Chapter 89 et seq.), to advise the Secretary of the Interior (the Secretary) and the Administrator, General Services Administration, (the Administrator) on policy and procedures for establishment of (and proposals to establish) commemorative works in the District of Columbia and its environs, as well as such other matters as it may deem appropriate concerning commemorative works. The Commission examines each memorial proposal for conformance to the Commemorative Works Act, and makes recommendations to the Secretary and the Administrator and to Members and Committees of Congress. The Commission also serves as a source of information for persons seeking to establish memorials in Washington, D.C., and its environs.

Any person may file with the Commission a written statement concerning the matters to be discussed. Before including your address, phone number, e-mail address, or other personal identifying information in your comment, you should be aware that your entire comment – including your personal identifying information – may be made publicly available at any time. While you can ask us in your comment to withhold your personal identifying information from public review, we cannot guarantee that we will be able to do so.
