Public Scoping Newsletter

The National Park Service (NPS) is developing a Trail Management Plan for Cabrillo National Monument.

Purpose and Need for the Trail Management Plan

The purpose of the project is to create a trail management plan to guide the course of trail management and development. Specifically, the plan will identify strategies, document decisions, and recommend actions to guide the development, maintenance, and use of the trail system, while also balancing these actions with resource protection, for the next 20 years. The plan is needed to:

- Assess visitor experience and visitor safety.
- Potentially improve connectivity between features of interest inside the monument (for pedestrians).
- Protect park resources through the decision-making process and subsequent actions.

Goals for the Cabrillo Trail System

The trail system:

- Is sustainable, meaning each trail lies lightly on the land, will last a long time, and needs little maintenance.
- Offers unique experiences and accessibility for a diversity of visitors during all seasons.
- Is well-marked and understood by visitors.
- Provides interpretive opportunities.
- Does not have unnecessary redundancy.

- Protects park resources and limits direct and indirect impacts from trail use.
- Minimizes the potential for conflict among different user groups.
- Improves pedestrian circulation and safety.
- Complements trail networks outside the park.
- Is within the park's personnel and budgetary resources.









Proposed Action

The planning team has developed a proposed action, which is the initial NPS proposal to address the plan purpose and need. The proposed action is one alternative that will be considered during the planning process. A proposed action is not a preferred alternative. The NPS will not select an alternative for implementation until after the planning process is completed.

The following trail proposals are numbered. The numbers correspond with general locations on the map on page 3. (Note: these are not final alignments.)

Proposed Action for Cabrillo Trails

New Trails:

- Provide pedestrian access to Tidepools from Visitor Center parking lot, considering one of three trail options:
 - A route from the Monument's upper parking lot to Parking Lot 3 (#1A on map)
 - A route paralleling Cabrillo Road (#1B on map)
 - A route from Bayside Trail to Parking Lot 1 (#1C on map)
- Construct an ABA¹ accessible trail along the road between Parking Lot 3 and Parking Lot 1 near the Tidepools (Trail #2 on map).
- Improve pedestrian access across Visitor Center parking lot.

Existing Trails to be Improved:

- Improve the Event Bluff Trail by narrowing the trail with post and rope and restoring denuded areas to natural condition.
- Enhance accessibility on the Bayside Trail, for example, through substrate improvements and modifications at water bars.
- Provide safety improvements / minor reroute of the existing trail at the Tidepool access point.
- Improve the Coastal Trail through the following actions:
 - Add a spur to roadside trail at searchlight structure
 - Narrow segments of the trail using post and rope or other delineation techniques, improve wayfinding signage, and restore denuded areas
 - Improve the staircase-spur that provides northern coastal access
- Restore user-created trails to natural conditions.
