## San Francisco Maritime National Historical Park is Proposing On-Line Reservations and a Fee for Anchoring Permits in Aquatic Park Cove

San Francisco, CA — On June 22, 2017, San Francisco Maritime National Historical Park proposes to begin using an online permitting system for sailing boats wishing to anchor out in the Aquatic Cove. It will be easier for visiting vessels to schedule and obtain permits by using the nationwide Recreation.gov reservation system, and the new system will aid the Park's efforts to increase visitor security, swimmer safety, and environmental compliance in this National Historic Landmark District.

In conjunction with the new online system, the park is proposing to implement a \$10 anchoring fee, which would bring the Aquatic Park Cove in line with existing artificial anchorage fee structures in the Bay Area. To make it easier for regular Cove users, the Park is also proposing to include a calendar year of anchoring fees in the purchase of its annual Park pass. Currently, the \$40 pass only offers entry to the fleet of historic ships at Hyde Street Pier.

"This modest fee will allow us to continue to protect, preserve and share the special places here at San Francisco Maritime National Historical Park," said Park Superintendent Kevin Hendricks. "After carefully considering the impact of this new system, and an anchoring fee, we came to the conclusion that this is the right course of action to improve services important to visitors and community members."

The park conducted a program review of its existing, paper-based permit system, and a comparability study of three different Bay Area sites that offer similar experiences, accessibility and amenities. The analysis showed that the park's present free anchoring permits are below similar operations and that, even with a fee of \$10, Aquatic Park Cove will remain one of the most affordable anchoring experiences in the Bay Area. The park feels this new system, and fee increase, is consistent with the public's desire for convenient, affordable, and sustainable recreational experiences.
