Description of Action (Project Description):

The test phase of winter and spring road plowing has highlighted the challenges the Mountain Vista trailhead faces as it struggles to serve a wide variety of winter recreational uses. The presence of tourists curious about winter recreation, potentially in large numbers, creates a level of visitor interaction and congestion that other winter trailheads in Denali don't experience. In order to provide for visitor, dog driver, and dog safety, this modifies the existing conditions near Mountain Vista and approves the following actions:

•Improved signage to better communicate trail locations and uses to visitors •Wands are to be added where germane to delineating the route •Only the yellow line (skier route) is authorized for any modifications at this time. No construction is to be done with respect to the red and blue lines (musher route leaving from Savage Cabin area; decisions about this area to follow upcoming winter planning effort/new EA) - please see map. •Trees at "pinch point" (SE-ish corner of general campground area) may be cleared to provide safer passage through that area and improved sight distance. •Brushing of "yellow" line to 8' wide is authorized up to the first creek crossing. •Puncheon to be removed - monitor skier trends this winter that result from removal.
