Comment Station # 1: What are the most important stories and people associated with the civil rights movement in the state of Mississippi?

- Have markers for lynching's at each individual site. Every site where a mob gathered should be remembered so we never do this again.
- There is still an underlying feeling of oppression in MS. We need to do more to engage heritage.
- There were 3 wade-ins not just bloody Sunday. The northern area needs to know more about the southern area & vice-versa.
- Kathy England from Hattiesburg, a member of NAACP. She is still alive and head of EECHO
 (Empowering, Economics, Environmental on Climate and Health Organization). She should be
 interviewed.
- Dr. Mason practiced medicine into his 90's. He helped everyone (Whites & Blacks) especially because they were poor. He didn't have a race barrier. He would trade chickens plus other things for payment. He helped others live a longer life through education his passionate medical treatment.
- Mr. Clay built a courthouse buried old city cemetery. Did other buildings. He took red brick and made spirals w/no rebar. They are still standing today.
- Black Fisherman (Mr. Ellis) came from LA w/ shrimp boats. They were independent & owners of their own boats. Mr. Ellis had 3 boats employed quite a few people.
- Dr. Mason known for wade-in protests, but his foundation was of a very professional & caring
 doctor who broke barriers in local medical field. Surgeons at the medical hospital, one of the
 first black residents of local hospital.

- Main Street Baptist Church meetings & hub. Our Mother of Sorrows Catholic Church/school
- Neighborhood walking area Main Division St. area. Ex. Perseme a house to show where they lived a normal 1960's African American home.

- 100 men Delta blue association in Bay St. Louis, a venue where African Americans performed when they couldn't perform elsewhere. Recently revived, restored. Blue note – black juke joint on Main Street.

 - o Dr. Mason Office & Wade-in beach & Division St. & Beck Park
 - Other NAACP Offices
 - o Travel through areas and visit points is more interesting than one site.
