

## **Buzzard Point Park Planning Update**

Buzzard Point Park is well on its way to becoming an enjoyable and unique community waterfront park. During 2018's Year of the Anacostia, we are celebrating the Anacostia River watershed, its history, the progress to the health of the river and the exciting things happening on its banks, like Buzzard Point Park. The National Park Service (NPS) envisions Buzzard Point Park as a place where everyone can go to relax and enjoy the Anacostia River.

We started the process to reimagine the park in the summer of 2016 and with your help, have created a vision for the new recreational opportunities and improvements the Park. Following a public planning and information session (held on July 14, 2016), a 30-day public comment period ending on August 15, 2016, as well as a stakeholder meeting (held on September 26, 2016), the NPS introduced the following two preliminary concepts for the Buzzard Point Park improvements at a public scoping meeting held on December 13, 2016:

**Concept 1** transforms the park into a linear waterfront and gateway park serving as the entrance to the Buzzard Point neighborhood. Proposed features include a continuation of the Anacostia Riverwalk Trail (ART) (designed as a multi-use trail with access for bikers and pedestrians alike) and a pedestrian-only promenade. The ART and pedestrian-only promenade would be separated by landscape features such as grass dunes and open lawn areas. The shoreline includes a terraced ledge to provide uninterrupted access to the water's edge.



**Concept 2** retains all the same park design features as Concept 1 (i.e., continuation of the ART, a separate pedestrian-only promenade, grass dunes, etc.), but places a portion of the ART on an elevated structure out in the river. By elevating the ART over the water, a unique park experience is created, with the potential to become a new D.C. attraction. Along the elevated trail, overlooks have been incorporated to take advantage of city and river views.



From December 2016 through January 2017, we received many helpful comments and suggestions during a 45-day comment period that helped us finalize the design concepts. In May 2017, the NPS published the Buzzard Point Park Development Concept Plan, which presented two concept designs for the park that included access and use of the ART. A copy of the DCP, which includes comment reports on both public meetings, and other related documents, can be found on-line at

NPS has decided to further evaluate the potential environmental impacts of Concept 1 in the EA.

This process will evaluate the current landscape of the area and determine the environmental impacts associated with the implementation of Concept 1. Therefore, Concept 1 will be further designed to a level appropriate to evaluate in the EA; a "No-Action" alternative would also be considered in the EA. It is anticipated that the Draft EA will be available for public comment in early Fall 2018. There will be an additional public meeting in early Fall 2018 to provide an opportunity for the public to comment on the Draft EA.

The purpose of our correspondence is to provide an update on the planned improvements at Buzzard Point Park and to facilitate further coordination with your agency as we move into the environmental review portion of the project.

Starting in the summer of 2016, the National Park Service (NPS) worked with the public and stakeholder groups to create a vision for the recreational opportunities and improvements to Buzzard Point Park. Following a public planning and information session (held on July 14, 2016), a 30-day public comment period ending on August 15, 2016, as well as a key stakeholder meeting (held on September 26, 2016), the NPS introduced the following two preliminary concepts for the Buzzard Point Park improvements at a public scoping meeting held on December 13, 2016:

**Concept 1** – transforms the park into a linear waterfront and gateway park serving as the entrance to the Buzzard Point neighborhood. Proposed features include a continuation of the Anacostia Riverwalk Trail (ART) (designed as a multiuse trail with access for bikers and pedestrians alike) and a pedestrian-only promenade. The ART and pedestrian-only promenade would be separated by landscape features such as grass dunes and open lawn areas. The shoreline includes a terraced ledge to provide uninterrupted access to the water's edge. This concept also proposes to repurpose the onsite Matthew Henson Earth Conservation Center in partnership with the Earth Conservation Corps to provide restrooms and other park support amenities.

**Concept 2** – retains all the same park design features as Concept 1 (i.e., continuation of the ART, a separate pedestrianonly promenade, grass dunes, etc.), but places a portion of the ART on an elevated structure out in the river. By elevating the ART over the water, a unique park experience is created, with the potential to become a new DC attraction. Along the elevated trail, overlooks have been incorporated to take advantage of city and river views.

In addition to the comments collected at the December scoping meeting, the NPS received many helpful comments and suggestions on these two concept designs during a 45-day comment period ending January 27, 2017. In May 2017, the NPS published the Buzzard Point Park Development Concept Plan (DCP). A copy of the DCP, which includes comment meetings, other related documents be found online reports on both public and can at http://parkplanning.nps.gov/BuzzardPointPark ea.

In accordance with the National Environmental Policy Act of 1969 (NEPA), the NPS is now preparing an Environmental Assessment (EA) to evaluate potential environmental impacts of the planned improvements at Buzzard Point Park. Based on the extensive public input received on the two preliminary concepts, NPS plans to provide a detailed analysis of the potential environmental impacts of Concept 1 in the EA. Therefore, Concept 1 will be further designed to a level appropriate to evaluate in the EA; a "No-Action" alternative would also be considered in the EA. It is anticipated that the Draft EA will be available for public comment in early Fall 2018. There will be an additional public meeting in early Fall 2018 to provide an opportunity for the public to comment on the Draft EA.

The NPS is committed to working closely with local government stakeholders to ensure the greatest compatibility of the improvements to Buzzard Point Park with the surrounding neighborhood. As transformation occurs within the neighborhood, new issues may come to light that should be further evaluated in the EA. Your assistance with identifying these issues is greatly appreciated, and the NPS would like to schedule an agency meeting to receive comments within your area of expertise.

## RE: Initiate Section 7 Consultation on Endangered Sturgeon in the Anacostia River by Buzzard Point Park Improvements Project, Washington, D.C.

Dear Ms. Damon-Randall:

The National Park Service is initiating informal Section 7 Endangered Species Act, as amended 1973, consultation for improvements to Buzzard Point Park, a part of National Capital Parks-East in southeastern Washington, D.C. along the Anacostia River (Attachments 1&2). Two species of sturgeon may be transient but are unlikely to be present: shortnose sturgeon (*Acipenser brevirostrum*) and the endangered Atlantic sturgeon (all five distinct population segments, (*Acipenser oxyrinchus oxyrinchus*). There is no designated critical habitat in the Anacostia River (Attachment 3, NMFS DPS Deck Map #10). The purpose of the project is to transform the park into a linear waterfront and gateway park serving as the entrance to the Buzzard Point neighborhood. Proposed features include a continuation of the Anacostia Riverwalk Trail (ART) designed as a shared use path and a pedestrian-only promenade. The ART and pedestrian-only promenade would be separated by landscape features such as grass dunes and open lawn areas.

#### **Project Description and Action Area**

The Anacostia River is a tributary of the Potomac River. The Buzzard Point Park Improvements Project begins approximately 2,350 feet northeast from the junction of the Anacostia and Potomac Rivers. Buzzard Point Park contains approximately 1,200 linear feet of shoreline along the Anacostia River. The proposed improvements include reconstruction of the shoreline to provide continuous access to the waterfront (Attachments 1&2).

#### **Description of Action**

The existing shoreline has four different edge treatments, including a concrete platform, concrete/stone revetments, a concrete boat ramp, and sections of natural shoreline comprised of rocks and vegetation. The existing concrete and stone structures are proposed to be removed as part of the project. The proposed shoreline would include constructing a terraced ledge along a portion of the shoreline. Reconstruction of other portions of the shoreline are proposed to include a softer, more natural shoreline (possibly including stone sills or breakwaters to dissipate wave energy) will be considered during the design process.

#### **Effects Determination**

By observing time-of-year restrictions from 15 February to 15 June, individual sturgeon of adult, sub-adult, or juveniles are unlikely to be exposed to any direct or indirect construction activities in the water. Furthermore, best management practices will reduce any amount of sediment or decrease in water quality that may occur from the in-river construction activities. There are no anticipated effects from the proposed action later in time or outside the Action Area.

#### **Conservation Measures**

To avoid or minimize the impacts to the extent possible, the following conservation measures will be implemented:

- The proposed work is located along the Anacostia River, which is outside of the designated Critical Habitat for the Atlantic Sturgeon Chesapeake Bay Distinct Population Segment (Attachment 3);
- Any in-river work would be completed outside of designated time of year restrictions from 15 February to 15 June;
- All appropriate best management practices for Sediment & Erosion control and stormwater management will be used during construction, to minimize impacts to water quality and aquatic habitat.

#### **Cumulative Effects**

Other projects along the Anacostia River such as the District of Columbia Department of Transportation/South Capitol Street Bridgebuilders pile driving in-river for the South Capitol Street/Frederick Douglass Memorial Bridge Project will likely be implemented to avoid or minimize project impacts to the sturgeon. Therefore, it is unlikely that adverse cumulative effects to the listed sturgeon would result from the proposed Buzzard Point Park Improvements Project.

#### Conclusion

Protections consist primarily of adhering to time-of-year restrictions and observing best management practices to minimize impacts to water quality and aquatic habitat to the maximum extent possible. Therefore, the National Park Service concludes that the proposed

activity may affect, but is not likely to adversely affect the federally endangered shortnose and Atlantic sturgeon. We request concurrence from NMFS on this determination.



Dear Ms. Beard:

The National Park Service is initiating consultation under the Fish and Wildlife Coordination Act, 16 U.S.C. 661-667e, as amended, concerning potential impacts to migratory fish and habitat by improvements to Buzzard Point Park in southwest Washington, D.C. along the Anacostia River (Attachments 1&2). As the project design progresses, we will apply for a US Army Corps 404 permit. The project is located on federal land administered by National Capital Parks—East, a unit of the National Park Service. The bottom of the Anacostia River within the District of Columbia is administered by the National Park Service. There is no Essential Fish Habitat defined for the Anacostia River. The purpose of the project is to transform the park into a linear waterfront and gateway park serving as the entrance to the Buzzard Point neighborhood. Proposed features include a continuation of the Anacostia Riverwalk Trail (ART) (designed as a shared use path) and a pedestrian only promenade. The ART and pedestrian-only promenade would be separated by landscape features such as grass dunes and open lawn areas. Specific planting plans will be prepared at a later design phase.

Buzzard Point Park contains approximately 1,400 linear feet of shoreline along the Anacostia River, a freshwater river. The proposed improvements also include reconstruction of the shoreline to provide continuous access to the waterfront. The existing shoreline includes four different edge treatments including a concrete platform, concrete/stone revetments, a concrete boat ramp, and sections of natural shoreline comprised of both rocks and vegetation. The existing concrete and stone structures would be removed as part of the project. The proposed shoreline would include a terraced ledge along a portion of the shoreline. Reconstruction of other portions of the shoreline are proposed to include a combination of stone sills, breakwaters, and vegetated areas to dissipate wave energy. The design of the river's edge will maximize the vegetated portion of the shoreline while protecting the shoreline from erosion. The current total area of estimated impacts into the Anacostia River is 56,000 square feet (1.29 acres).

A review of the Virginia Institute of Marine Science (VIMS) mapping for submerged aquatic vegetation (SAV) indicated that an area of potential SAV occurs directly off the shoreline in the project area, as shown in Attachment 3. Based upon VIMS mapping, the species of SAV that are potentially impacted include hydrilla (*Hydrilla verticillate*), water stargrass (*Heteranthera dubia*), coontail (*Ceratophyllum* 

demrsum), and wild celery (Vallisneria americana). Impacts to the SAV area will be unavoidable due to the need to reconstruct the failing concrete/stone revetments at the site. The loss of SAV will be temporary. We expect the SAV to recolonize once the project ends. Additionally, we propose to increase the riparian and in-water vegetation by maximizing as much of natural shoreline as practicable, which will minimize the adverse impacts of such actions on fish and wildlife resources and habitat. Further conservation measures we will follow are:

- Any in-stream work would be completed outside of designated time of year restrictions for migratory fish (15 February to 15 June) in the Anacostia River;
- All appropriate best management practices for Sediment & Erosion control and stormwater management would be used during construction. Monitoring will also be done to ensure no sediment threatens downstream species and habitat.

The National Park Service concludes that there is no essential fish habitat in the action area. The National Park Service has determined that the activities associated with the Buzzard Point Park Improvements project are not likely to adversely affect migratory fish or their habitat.

Dear Ms. Stidham:

We have reviewed the information you provided to us regarding the above referenced project. Until design progresses and you can provide us with project plans, we can only provide you with general guidance. As you move forward with project design and apply for your Department of the Army Permits, please continue to coordinate with us so that we can provide more specific recommendations.

We offer the following preliminary comments pursuant to the Fish and Wildlife Coordination Act, the Magnuson-Stevens Fishery Conservation and Management Act, and Endangered Species Act,

### Fish and Wildlife Coordination Act

The Anacostia River provides habitat for a variety of NOAA trust resources. It serves as nursery and forage area for anadromous fish such as alewife, blueback herring, American shad, and hickory shad, and herring spawning is documented to occur in the area. Efforts should be made to avoid and minimize adverse effects to the aquatic environment, particularly related to the release of suspended sediment in the waterway. Depending on project specifics, time of year restrictions may be necessary to protect migrating and spawning fish during in-water work. Work that would impact submerged aquatic vegetation (SAV) (e.g., from the use of equipment, placement of material, or turbidity) should be restricted during the SAV growing season from April 15 through October 15.

### Magnuson-Stevens Fishery Conservation and Management Act – Essential Fish Habitat

The project location is within the tidal freshwater portion of the Anacostia River. Essential fish habitat (EFH) has only been designated in the mixing zone and seawater portions of the Chesapeake Bay, therefore there is no EFH designated in the project area.
