A. PROJECT INFORMATION

Title: Tenaya Lake Murphy Creek Picnic Area RestorationLocation: Tenaya Lake, Tuolumne County, CaliforniaProject Manager: Monica Buhler, Resources Management and Science, Yosemite National Park

B. PROJECT DESCRIPTION AND BACKGROUND

This project will restore native vegetation and protect the highly impacted subalpine lakeshore of the Murphy Creek Picnic area at the northwest end of Tenaya Lake. There are two compacted dirt parking areas (east and west) included in the project area. The poor definition of the parking areas has resulted in vehicles moving further into the forest and closer to the lakeshore (even onto the beach). This parking lot "creep" compacts soils, destroys native vegetation, and increases the area of impact. Picnic sites are not clearly defined and picnic tables have been moved to the beach where inappropriate campfire rings are established. There are many informal trails, from the parking areas to the lakeshore, braiding through the forest and the riparian areas of Murphy Creek. Delineation of parking areas, picnic sites and paths to the lake while focusing visitor use to less sensitive areas, would minimize impacts to natural and cultural resources.

Proposed Actions:

- Resolve hydrology problems in parking area by grading the area and possibly laying down gravel.
- Delineate parking areas with boulders and logs.
- Remove and replace old picnic tables and move and secure them in areas 100 feet or more from the high water level.
- Remove and rehabilitate inappropriate campfire rings and keep them at least 100 from the high water level.
- Establish a picnic site according to Americans with Disabilities Act (ADA) standards.
- Minimize the number of social trails.

• Remove, decompact (by hand and with a bobcat), mulch, and re-vegetate social trails and inappropriate picnic sites.

- Move garbage cans closer to the parking area.
- Install area information signs.

Site design will be coordinated by an inter-divisional group to address natural resource protection, maintenance issues, law enforcement issues, and visitor impacts. The design of an ADA accessible picnic site will be according to the most current guidelines and with recommendations from the park ADA requirements specialist.

Boulders would be gathered on-site and from staging locations in the park (i.e. south landing). The Forestry Crew would supply logs from the hazard tree removal program. Both would be assessed for weeds before moving them into the area.

The project area has been surveyed for cultural resources and no sites have been documented. There are three sites adjacent to the project area, but they would not be impacted.

This project will not address the parking or design of the Murphy Creek Trailhead which will be included in a larger Tuolumne area trailhead improvement project.






