National Capital Memorial Advisory Commission Notice of Public Meeting

A meeting of the National Capital Memorial Advisory Commission (the Commission) will be held on **Tuesday, February 11, at 12:30 p.m.**, in the National Capital Planning Commission meeting chambers, 401 9th St NW, Washington, DC 20004.

Agenda

The Commission will review:

1. **H.R. 5046**, a bill to authorize the location of a memorial on the National Mall to commemorate and honor the members of the Armed Forces that served on active duty in support of the Global War on Terrorism,
2. **H.R. 5173**, a bill to authorize the National Medal of Honor Museum Foundation to establish a commemorative work in the District of Columbia or its Environs,
3. **H.R. 3349**, a bill to authorize the Daughters of the Republic of Texas to establish the Republic of Texas Legation Memorial as a commemorative work in the District of Columbia,
4. **H.R. 5068**, a bill to authorize the Women Who Worked on the Home Front Foundation to establish a commemorative work in the District of Columbia or its Environs,
5. Design for Second Division Memorial modification,
6. Design for Korean War Veterans Memorial Wall of Remembrance,
7. Design for National Desert Storm and Desert Shield Memorial,
8. Design for Peace Corps Commemorative Park,
9. Other business.

The Commission was established by Public Law 99-652, the Commemorative Works Act (40 U.S.C. Chapter 89 et seq.), to advise the Secretary of the Interior (the Secretary) and the Administrator, General Services Administration, (the Administrator) on policy and procedures for establishment of (and proposals to establish) commemorative works in the District of Columbia and its environs, as well as such other matters as it may deem appropriate concerning commemorative works. The Commission examines each memorial proposal for conformance to

the Commemorative Works Act, and makes recommendations to the Secretary and the Administrator and to Members and Committees of Congress. The Commission also serves as a source of information for persons seeking to establish memorials in Washington, DC, and its environs.
