3.0 RESPONSE TO COMMENTS

This Chapter of the Final EIS presents all comments received on the Draft EIS, followed by the NPS's response to each substantive comment. Comments were presented to the NPS during the 60-day review period for the DEIS which closed on December 7, 1998. Comments include written letters, e-mail messages, and oral testimony given during the November 18, 1998 public hearing on the Draft EIS. A total of 127 letters, e-mail messages, and oral testimonies were received (Table 1).

Each comment letter, e-mail message and oral comment is assigned a number, 1 through 127. Within each letter/testimony, the substantive comments raised are outlined in the right margin and assigned a letter (A through Z). A number/letter combination is used to identify each substantive comment. For example, the second comment presented in letter # 4 would be numbered "4-B." This numbering system is then keyed to the responses which follow each letter.
