The Superintendent and park interdisciplinary team have reviewed the proposed project and completed an impact analysis and documentation, and have determined the following:

- There will not be any effect on threatened, endangered, or rare species and/or their critical habitat.
- There will be no adverse effect to historic properties.
- There will not be serious or long-term undesirable environmental or visual effects.

The subject proposed project, therefore, is now cleared for all NEPA and NHPA compliance requirements as presented above. Project plans and specifications are approved and construction and/or project implementation can commence.

Required Mitigations - For the proposed project actions to be within compliance requirements during construction and/or project implementation, the following mitigations must be adhered to:

- The SHPO and regional historical architect recommended that the park avoid the use of wall-mount brackets for the installation of televisions in the guest rooms and continue to have televisions placed on top of the furniture. While use of wall-mounting brackets would be reversible, avoiding this action would reduce the effects to this National Historic Landmark building by limiting penetrations of the historic plastered walls. For the smaller rooms, placing the televisions on the furniture would not meet project objectives to achieve hospitality industry standards for hotel room furnishings. An attempt was made to construct brackets that would raise the televisions above the furniture but required additional wall penetrations to stabilize the furniture made top-heavy by the television and brackets. This also did not meet the industry standards for furnishings.
- Please consider painting rather than wallpapering the elevator lobby and choosing bathroom light fixtures that are more compatible with the design of the hotel.
- The park understands that the proposed products may no longer be available from manufacturers. The park requires that any changes to the proposed fabrics, furniture pieces, or fixtures be provided for park review prior to purchasing.

Description of Action (Project Description):

JUSTIFICATION: The Suites at the Ahwahnee Hotel are typically refurbished when updates are needed to improve the guest experience per the business practices of the current concessioner. Just as the guest rooms were updated in 2017-18, the Suite rooms are proposed to be updated. The proposed undertaking would include the refurbishment of the spaces consistent to the extent possible with the treatment recommendations in the Ahwahnee Historic Furnishings Report (ARG 2011) and the Ahwahnee Historic Structure Report (ARG 2011). Yosemite Hospitality has contracted with Kollath McCann Creative Services for the design.

SCOPE: • Replace carpet • Paint the rooms (historic stencils would be protected) • Install wallpaper in some locations • Replace wall sconces adjacent to the beds • Mount the flat screened televisions onto the walls in small bedrooms (will include wall penetrations for mounting, electricity and cable access will be run in conduit painted to match wall) • Replace non-historic draperies and hang new ceiling-mount valance similar to guest rooms taking care to avoid damage to historic stencils • Replace and refurbish furnishings in select locations • Replace bathroom light fixtures and hardware

Room 118 "Diggins" (non-historic) Relocate chandelier with painted surface-mounted conduit, re-route co-axial cable around perimeter of the room under new carpet. This arrangement takes better advantage of natural light.

230-232-234 "the Presidential" and 330-332-334 "Third Floor Suite" (contributing, significant spaces in hallways and in the parlors) New furnishings, balcony furniture includes patio heaters and fire table, wall-mount TVs in bedrooms, glass top on reserve property desk

6th Floor Elevator Lobby (contributing) Wallpaper and paint

601 "The Mather" and 607 "The Spencer (contributing) New furnishings

603 "The Sunporch" (significant) Carpeted, refresh bead-chain roller shades with new fabric trim, new sofa, side tables, and table lamps,

605 "The Tressider/Queen's Room (contributing) New sconces and window treatments and new furnishings

602 "The Underwood" (contributing) Replace dresser with new wider piece with 8 drawers, replace Georgian side chair

RESPONSE TO HSR RECOMMENDATIONS: Treatment recommendations in the 2011 HSR and 2011 HFR are largely out of scope for this project. The contract requirement to upgrade soft goods does not include accessibility upgrades and site and civil upgrades. The scope of this project does not address plumbing fixtures, ceiling fans, door hardware, wood trim,

structural and mechanical systems, or life safety upgrades. Following is the only treatment recommendation from the HSR that will be addressed:

Colors, patterns, and textures proposed are consistent with the period of significance.

Excerpts from the HFR: "If the hotel operator's future goal is to revive the concept of the historic interior scheme as it was during the period of significance, changes should re-emphasize the polychromatic vibrancy of features, elements, and finishes, re-introduce bold, colorful patterns, and have little impact on original furniture and furnishings. Consideration should be given to the residential character achieved through the use of small-scale furnishings throughout the hotel and the warmth conveyed by comfortable, upholstered seating and Alpujarras and Khilim rugs on the floor and on the walls."

The first phase of work is scheduled to begin in 2020.

Mitigation(s):

- The SHPO and regional historical architect recommended that the park avoid the use of wall-mount brackets for the installation of televisions in the guest rooms and continue to have televisions placed on top of the furniture. While use of wall-mounting brackets would be reversible, avoiding this action would reduce the effects to this National Historic Landmark building by limiting penetrations of the historic plastered walls. For the smaller rooms, placing the televisions on the furniture would not meet project objectives to achieve hospitality industry standards for hotel room furnishings. An attempt was made to construct brackets that would raise the televisions above the furniture but required additional wall penetrations to stabilize the furniture made top-heavy by the television and brackets. This also did not meet the industry standards for furnishings.

Cultural Prehistoric/historic structures	Potential	Issue: The HFR and HSR were consulted for the development and refinement of this project proposal. Much discussion regarding mounting televisions on the walls which would create new wall penetrations into the historic plaster. Industry standards require the furniture surfaces to be relatively clear of appurtenances and visitor safety requires that televisions be mounted solidly.
		Wallpaper is not original to the 6th floor elevator lobby but there was a strong feeling that guests needed a distinct and immediate sense of arrival when entering this unique space. Work that was approved prior to having the benefit of the HSR and HFR doesn't justify continuing that approach. It is a space that has been altered over the years so the wallpaper is not a deal breaker, but is definitely not preferred.
		Off-the-shelf sconces and bathroom light fixtures do not compliment the historic features of the building but did not constitute an adverse effect.
		Overhead fixtures in the rooms are being custom made to match other fixtures used in the building with the Ahwahnee motif.

My comment for that project were as follows: "The designers should be given a copy of the Historic Furnishings Report and encouraged to follow the recommendations. Curtains, bedding and carpets should be simplified patterns rather than the bold floral patterns proposed and should be compatible with, rather than over powering, the historic stenciling in the rooms. Light fixtures should also be a simple design selected to be compatible with the historic character of the hotel. Modern expectations would not support replicating the original rooms but it is possible to design modern luxurious rooms with an elegant simplicity compatible with the character of the Ahwahnee and that should be the goal. One of the reasons guests choose the Ahwahnee is it's historic character and th room design should embrace that character. The proposed changes will have only minor impact on historic materials, resulting in a determination of no adverse effect. The changes will diminish the historic character of the rooms but will not affect more significant public areas. The changes are temporary, generally redone on a cycle of less than every ten years." Unfortunately not only was the design not revised for those guest rooms, over two years later it is being proposed again, this time for the suites. While this again does not rise to the level of adverse effect due to the limited impact to historic fabric and the fact that the impacts are to the character of the guest rooms rather than the more significant public spaces.
