This is not referring to upgrades to handle a larger capacity of electricity or people. It's an upgrade.

Erika Espaniola: To repair the system to serve the same amount of people in the capacity, the upgrade is referring to getting the system more efficient, more reliable and up to code and I'll turn it over to David fudge for the next slides and David is in our MPs Denver service center.

David Futch: Thank you. Erica. Appreciate it as Erica mentioned, my name is David fudge. I work in the design and constructions portion of the Denver service center in Denver, Colorado, and I work closely with the design and consultants working to design and eventually construct this project.

David Futch: The purpose of the project goes back several years. But what tends to happen is that there are frequent power outage outages, about eight to 10 times during out throughout the year. This

David Futch: And the reason for that is that during the power outages. The park has to bring in subject matter experts or certified high voltage electricians to come in and operate and maintain the system during their maintenance. It takes about three to five days to make the repairs.

David Futch: And that includes working 24 seven the impact to the park and the surrounding areas is about \$23,000 a year for this emergency operation and maintenance, just to maintain it.

David Futch: The other reason for the project and the need is that the Kalaupapa staff does not have the certified, high, high voltage electricians on to maintain the system throughout the year. So they rely on help from Mikko in order to make the corrections and repairs at the park.

David Futch: This included looking at alternative energy, energy solutions at two locations and we'll get into some of those locations. Further, but essentially what it is is that in one location solar wasn't really a

David Futch: Solar wasn't a good idea because of the shape cover and solar panels being added or near the settlement, there wasn't enough power generated from the solar panels to actually make the process in energy use viable in the settlement.
