

# **Meeting Purpose**

### What is NEPA?

- The National Environmental Policy Act (NEPA) is part of a planning and decision-making process.
- NEPA requires federal agencies to:
  - Analyze the environmental impacts of federal actions; and
  - Engage the public in the decision-making process.
- The goal is to ensure informed decision-making.



# **NEPA Planning Process**

- Conduct public scoping to determining the range of issues to be addressed and for identifying issues related to the proposed action. Completed in mid-2021.
- Document affected environment, determine environmental consequences, and develop mitigation measures: Completed, spring, 2022
- Prepare EA for public review: Completed, July 10, 2022
- Public Review and Comment: July 11 through August 11, 2022




### What is NHPA?

- The National Historic Preservation Act (NHPA) establishes a process (Section 106) for federal agencies to consider the effects of their actions on historic properties listed in, or eligible for listing in, the National Register of Historic Places.
- Can conclude in a determination of No Adverse Effect or a Memorandum of Agreement with Consulting Parties.
- The goal is to avoid and minimize potential harm to historic resources.


# **Project Background**

- Rock Creek Park established by Congress on September 27, 1890.
- Congress specifically authorized construction of driving roads and trails for horses and pedestrians, while mandating that park resources be preserved "in their natural condition, as nearly as possible."
- First closures for recreation in 1966.
- Grew to include additional sections of Beach Drive and other park roads.
- Closures were extended to include Saturdays and federal holidays.



# **Project Background: The GMP**

- Rock Creek Park and the Rock Creek and Potomac Parkway Final General Management Plan/Environmental Impact Statement (GMP).
- Upper Beach Drive open to motor vehicles on weekdays, and closed for recreational use on weekends, Federal holidays.
- Non-recreational through-traffic would be accommodated in the park.

## **Project Background: COVID Closures and the**

**Management Plan** 

- Weekend/holiday closures temporarily extended during COVID public health emergency.
- Undertaken to provide visitors with safe recreational opportunities.
- Park staff observed increased weekday non-motorized recreational use roadways.
- Temporary closures have been extended until September 5, 2022.

## Purpose and Need for Management of Upper Beach Drive

The <u>purpose</u> of the plan is to develop a comprehensive management approach for upper Beach Drive and adjacent roadways that accounts for the **needs of motorized and non-motorized users** while **minimizing impacts to park resources**. If existing park management strategies change, this plan will also serve to amend the General Management Plan regarding management of these park roadways.

This plan is <u>needed</u> to better understand possible long-term changes in the use of upper Beach Drive and adjacent roadways, and to determine if existing park management strategies need to change as a result.



### **Alternative 1: Pre-COVID Pandemic Management**

Closing the following roadways on weekends and holidays:

- Bingham Drive
- Sherrill Drive
- Beach Drive in three sections: 1) Broad Branch Road to Joyce Road; 2) Picnic Area 10 to Wise Road; and 3),
   West Beach Drive to the Maryland boundary.

Between Joyce Road and Picnic Area 10, Beach Drive would remain open to vehicles only for the purpose of providing access to group picnic areas and parking lots.

Ross Drive would remain open at all times.





#### **Alternative 2: Full-Time Closure for Recreation**

Closing the following roadways year-round:

- Bingham Drive
- Sherrill Drive
- Beach Drive in three sections: 1) Broad Branch Road to Joyce Road; 2) Picnic Area 10 to Wise Road; and 3), West Beach Drive to the Maryland boundary.

Between Joyce Road and Picnic Area 10, Beach Drive would remain open to vehicles only for the purpose of providing access to group picnic areas and parking lots.

Ross Drive would remain open at all times.





#### Alternative 3: Seasonal Closure for Recreation – NPS Preferred

Closing the following roadways to motor vehicle use between Memorial Day and Labor Day weekends, and on weekends and federal holidays after Labor Day and before Memorial Day:

- Bingham Drive
- Sherrill Drive
- Beach Drive in three sections: 1) Broad Branch Road to Joyce Road; 2) from Picnic Area 10 to
   Wise Road; and 3) from West Beach Drive to the Maryland boundary.

Between Joyce Road and Picnic Area 10, Beach Drive would remain open to vehicles only to provide access to group picnic areas and parking lots.

Ross Drive would dopen to vehicles at all times.



## Why the Preferred Alternative?

- Allows for greater park access by active recreational users when people are on vacation and when visitation is generally highest, and on every weekend and federal holiday throughout the year.
- Creates safer conditions during the summer by reducing conflicts between motor vehicles, bicyclists, and pedestrians, and provide routes for cyclists, largely free of motor vehicles, between the north end of the Rock Creek Park Multi-Use Trail and the Maryland state line.
- Provides nonmotorized access for persons with disabilities to areas of the park that lack separated pathways and accessible trails.
- Provides for decreased effects to the local transportation network during the period when traffic volumes are highest.
- Provides protection and preservation of wildlife and habitat for several park species, as dense vegetation prohibits visitors' desire and ability to create and use unofficial trails that impact forest habitat.


