



# Establishment of the Monument



- 405th NPS unit, established on December 29th, 2014, through the National Defense Authorization Bill
- 22,650 acres transferred from Bureau of Land Management
- Previously allowed wide range of activities and nearly unlimited access which has resulted in degraded resources
- Establishment as a NPS unit focuses on resource protection, environmental remediation, and visitor health and safety



# Park Purpose

Tule Springs Fossil Beds National Monument conserves, protects, enhances, and interprets late Pleistocene fossils, their geologic context, and other scientific values in the upper Las Vegas Wash through education, research, community collaboration, and appropriate public use.

# What is a General Management Plan?

- General management plans set long-term goals for the park and provide broad direction for resource preservation and visitor use.
- Provide flexibility for decision making and serve as a basis for future implementation planning.
- GMPs address:
  - Preservation of resources
  - Types and intensities of development
  - Visitor capacity
  - Boundary modifications

- Consider the relationship between park visitors and local communities.







# Proposed Draft Management Zones

The National Park Service is beginning a comprehensive planning effort for Tule Springs Fossil Beds National Monument. The result will be a new General Management Plan (GMP) that will guide park management for the next 20 years or longer. All national park units are required to have an approved general management plan. The National Park Service will work with its partners, the public, and its stakeholders to develop the plan and to comply with legal and policy requirements.

The general management plan for Tule Springs Fossil Beds National Monument will provide a framework to guide decisions for long-range park management. The plan will also define the desired resource conditions and visitor experiences that should be achieved and maintained based on the park's purpose and significance and as described in the park's authorizing legislation and foundation document. This plan will set the direction for subsequent and more focused planning efforts, as well.
