Authority

- National Park Service (NPS) manages the lands and waters within the Park boundary
- NPS can establish areas that have special restrictions or closures.
- A No Wake Zone would be one of those areas that may be established by the Park's Superintendent as determined by its need
- A No Wake Zone would initially be established and published in the Superintendent's Compendium for Cape Hatteras National Seashore.
- Later it would be added as part of 36 CFR 7.58 special regulations for Cape Hatteras National Seashore.

The Need for a No Wake Zone

- Improve Safety at intersection of multiple channels
- Reduce visitor use conflicts
- Provide safe fueling operations
- Protect submerged vegetation in shallow water
- Protect shoreline from erosion

North Carolina Wildlife Resources Commission (NCWRC) – wake zones language

- "No Wake Zones may be established in public trust waters only to mitigate hazards to boating safety. Hazards to boating safety may include known navigational hazards; narrow shallow waters; areas of obstructed vision; structures in the area such as dams, spillways, flood control structures, trestles and power lines, and fueling docks; designated recreational or marked swimming areas; congested areas with high traffic; a history of accidents, and public vessel access areas."
- NCWRC has been briefed on our project proposal and will be considering a complimentary state rule
- NPS No Wake Zone would be established to mitigate hazards in this areas including narrow/shallow water, fueling dock, congested areas and public vessel access areas.



Use of the NPS owned area

- 5 Boat launch lanes (NPS)
- 78 Boat trailer parking spots (NPS)
- Bathroom facility (NPS)
- 1 kayak launch
- 50 + slips at OIFC and over 40 charters (lease)
- 200 + parking spots near the marina (lease)
- Transient fuel dock (lease)
- USCG station Oregon Inlet (lease)

Project Details

- The area would be established using pilings installed with signage
- Signs indicating the No Wake Zone would be placed at the public boat ramp
- A no wake buoy would be placed in the marina area
- Park maps would be updated to reflect the change
- Zone would be codified in the Superintendent's Compendium
- Notification provided to other agencies including: USCG, NCWRC, National Oceanic and Atmospheric Administration and NC Marine Fisheries.



Proposed No Wake Zone

- Lies within the park boundary
- Dissipation of wake to the shallow areas of congestion where multiple users are present
- Dissipation of wake that has been impacting the north shoreline and marsh vegetation erosion
- Minimize impacts to the boat launch and transient fuel dock






Comparison

Current No Wake
Zone at Pirates
Cove/Washington
Baum Bridge

Launch

- -Approximately 1,213 feet out
- -Approximately 1.185 feet wide



No Wake Zones are common in busy NC waters
