2. Site selection	3/12/2026	Adams Family Memorial	In Fall 2020, President Trump made two of the four presidential appointments to the Commission. The Commission will also include eight congressional appointees. The Commission expires December 2, 2025.
2. Site selection	11/3/2025	EMS Memorial	Sponsor is developing design concepts and refining the site selection study.
3. Design	12/22/2027	Texas Legation	Sponsor engaged in design development in preparation for concept design submissions to the CFA and NCPC.
3. Design	1/1/2028	First Division modification	Sponsor engaged in design refinement in preparation for final design submissions to the CFA and NCPC.
3. Design	12/12/2024	Second Division modification	Sponsor is developing construction documents. The project received final CFA and NCPC design approvals.
3. Design	3/31/2024	Desert Storm / Desert Shield	Sponsor received NCPC and CFA concept design approval and is seeking final approvals this fall or winter
3. Design	1/24/2028	Peace Corps Park	Sponsor received preliminary NCPC approval in September and is working on final CFA and NCPC design submissions.
