The Superintendent and park interdisciplinary team have reviewed the proposed project and completed an impact analysis and documentation, and have determined the following:

- There will not be any effect on threatened, endangered, or rare species and/or their critical habitat.
- There will be no adverse effects to historic properties.
- There will not be serious or long-term undesirable environmental or visual effects.

The subject proposed project, therefore, is now cleared for all NEPA and NHPA compliance requirements as presented above. Project plans and specifications are approved and construction and/or project implementation can commence.

Required Mitigations - For the proposed project actions to be within compliance requirements during construction and/or project implementation, the following mitigations must be adhered to:

- Trailer should be painted brown to match existing park structures at Arch Rock.
- All staff will be advised to obey park speed limits, exercising extra vigilance during rainy conditions to avoid vehicle strikes of frogs/toads that may be crossing the roadways. All food and trash will be stored in accordance with park regulations.
- No digging is permitted.

- Measures shall be taken to prevent the introduction of exotic species in the project area and staging areas. All earth moving equipment must enter the Park free of dirt, dust, mud, seeds, or other potential contaminant. Examples of equipment that require inspection are excavators, skid steers, or boring equipment. Passenger vehicles do not need inspection but should be clean prior to entry in the park. Equipment exhibiting any dirt or other material attached to frame, tires, wheels, or other parts shall be thoroughly cleaned by the Contractor before entering the Park. Areas inspected shall include, but not be limited to, tracks, track guard/housings, belly pans/under covers, buckets, rippers, and other attachments. Equipment that does not pass inspection will be turned around to the nearest cleaning facility outside the park. The Contractor shall notify the Construction manager at least two working days (not including weekends) prior to bringing any equipment into the park. Equipment found to have entered the park with potential contaminants will be removed from the park at the direction of the Contracting Officer at Contractor's sole expense. All staff working on site shall be informed of and follow best management practices for preventing the introduction and spread of non-native, invasive species as described in Division 1 Specifications, Section 1335.
- Only work specified in PEPC 109771 is approved for implementation. Changes to the scope of work require additional review and approval by the Yosemite Environmental Planning and Compliance Office.

Description of Action (Project Description):

Rental of one mobile office trailer for one year and up to four option years from August 1, 2022, through September 30, 2027, to provide temporary office space for park staff at Arch Rock Entrance Station. The Trailer will be 10-12 feet long by 30-32 feet wide with an interior height of 8ft. Hook-ups will be above ground and connected in house to the existing utilities. If trailer cannot be hooked to sewer an above ground storage tank will be placed next to the trailer and pumped out on a regular schedule. Trailer will be placed in the farthest southwest corner of the parking lot closest to the house.

The current office space is 72 square feet and doesn't serve the operation or the employees adequately. The one-room office functions include: supervisor duties, remit and other administrative functions, employee break room, and storage for up to 17 staff members. Due to the pandemic and implementation of a managed access system, increasing space for entrance station employees has become a safety issue and a priority. The supervisor requires a private space and staff deserve a restroom and running water. The temporary trailer will provide a dedicated space for the supervisor, an area for administrative functions and staff breaks, as well as a restroom. Suitable space could be found in the existing housing area next to the entrance station. The housing unit has been the entrance station office the past two years but no longer approved and the space will be returned to seasonal housing.

The trailer will feature fluorescent ceiling lights (120/240 volt) with a single-phase electric 100-amp breaker panel. The body construction will have wood siding or synthetic comparable siding. The paint color will match surrounding Arch Rock structures. The trailer will include an operational bathroom with a toilet and sink. The service utility lines are provided by the contractor to connect to existing plumbing and electric system. Finally, the trailer will include one private office.

CE Justification:

The installation of a temporary trailer has as similar, if not lesser, impact than the installation of a well, comfort station or pit toilet. Additionally, the location of this trailer is in an area of existing development (paved parking lot).

No	This project will place a small, temporary trailer in a paved parking lot. The trailer will add a non-historic element to the Arch Rock Entrance Complex. However, due to the temporary nature of the trailer, the small footprint and the location in a developed area we do not expect the trailer to have a significant impact on park resources. The trailer will be placed within 150-feet of the Merced River but due to it's location in a paved parking lot we do not expect it to alter river ecology in any way.

Historical Structures/Resources Notes: This project includes CA-MRP-1705H. This recorded site is the Arch Rock Entrance Station Complex. The complex includes five structures and a parking area serving as the initial visitor contact station at the El Portal entrance to Yosemite. A ranger residence, dorm housing, and a utility building and public restroom form a U-shaped structure adjacent to the visitor parking area (Buildings A-C). The complex also includes the entrance kiosk (Building E) and a small octagonal building that was originally constructed as one of two entrance check stations and now functions as an office (Building D). Buildings A-C were constructed in 1925-1926 and Building D was constructed in 1926 to accommodate the newly completed El Portal Road "All Year Highway." These structures were designed and built on a simplified NPS rustic design found throughout the park. The checking stations were moved and realigned in 1928 to accommodate the influx of more visitor traffic. Building E was constructed in 1961 to replace the original kiosk which had experienced deterioration and damage from vehicle traffic.

The project also includes CA-MRP-1702H. This recorded site is the El Portal Road.

Comments: The limited footprint of the proposed structure within the parking lot adjacent to the Arch Rock Entrance Station will have a minimal effect on the cultural landscape so long as steps are taken to make the appearance of the trailer harmonious with its surroundings.

Temporary trailers across the Valley employ this color strategy, and are usually successful in meeting the short term, immediate demands of the NPS while minimally detracting from the integrity of the historic landscape.
