Landscape Management Plan

Antietam National Battlefield Sharpsburg, Maryland

The National Park Service (NPS) prepared a Landscape Management Plan/Environmental Assessment (Plan) to evaluate the potential environmental impacts associated with changes in the management of the landscape to maintain and enhance the historic character of Antietam National Battlefield (the Battlefield), an administrative unit of national park system located in Sharpsburg, Maryland. The purpose of the Battlefield is to preserve, protect, restore, and interpret for the benefit of the public the resources associated with the Battle of Antietam and its legacy. The Plan amends the scene restoration and resource management portions of the 1992 Antietam National Battlefield General Management Plan (GMP) addressing lands acquired since 1992 not considered in the GMP and evolving management decisions regarding the management of the historic battlefield landscape.

The purpose of the Plan is to develop comprehensive, sustainable land use strategies that will preserve significant landscape elements and integrate natural and cultural resource values. The Plan will define the framework for the treatment of the Battlefield and commemorative landscape and describe specific guidelines and tasks aimed to maintain and enhance its historic character.

The Plan is needed because:

- The 1992 GMP provides inadequate and outdated Scene Restoration and Resource Management guidance
- The Battlefield has more than doubled in size since the 1992 GMP
- Existing park guidance does not address appropriate preservation treatment for the entire battlefield cultural landscape as it is currently defined
- The landscape has been managed in a piecemeal manner
- Invasive species and pests present a growing challenge to Battlefield-wide stewardship
- Erosion occurs along creeks and trails, diminishing Battlefield resources
- The Battlefield experiences loss or diminishment of witness trees
- The Battlefield is evaluating a long-term lease program for farm operation and improved watershed stewardship
- The landscape lacks sufficient resiliency to address climate change impact

The Environmental Assessment (EA) was prepared in accordance with the National Environmental Policy Act (NEPA) (42 United States Code (USC) § 4332) and the Council on Environmental Quality implementing regulations effective September 14, 2020 (40 Code of Federal Regulations (CFR) §§ 1500-1508); US Department of the Interior NEPA regulations (43 CFR 46); NPS Director's Order 12: Conservation Planning, Environmental Impact Analysis, and Decision-Making; and the NPS NEPA Handbook. The statements and conclusions reached in this finding of no significant impact (FONSI) are based on documentation and analysis provided in the EA and associated decision file.

PUBLIC AND AGENCY INVOLVEMENT

Public Scoping – As part of the NEPA process and to comply with the requirements of Section 106 of the National Historic Preservation Act (NHPA), the NPS involved the public in project scoping by holding a 30-day public comment period from October 21, 2021, to November 21, 2021. A virtual public meeting was held on October 21, 2021, using the Microsoft Teams platform. The scoping period and virtual meeting were announced by sending an email blast to agencies, stakeholders, and other potentially interested parties from a mailing list established for the project. The presentation used during the virtual public meeting and a recording of the meeting remain available at the NPS Planning, Environment and Public Comment (PEPC) project webpage

(https://parkplanning.nps.gov/document.cfm?parkID=173&projectID=104934&documentID=115828). A total of 11 correspondences were received during the public during the scoping period.

EA Public Review – The EA was made available for public review and comment from July 7, 2022, to August 8 at the NPS PEPC project webpage

(https://parkplanning.nps.gov/document.cfm?parkID=173&projectID=104934&documentID=115828). The EA public review period was announced on the NPS PEPC project webpage and by news release and email blast. A total of nine correspondences were received during the EA public review period. Responses to public comments are provided in Attachment B.

National Historic Preservation Act, Section 106 Consultation – Section 106 of the National Historic Preservation Act (543 USC 306101) and its implementing regulations (36 CFR Part 800) requires federal agencies to take into consideration the effects projects have on historic properties. In alignment with Section 106 and the Programmatic Agreement Among the National Park Service, the Advisory Council on Historic Preservation, and the National Conference of State Historic Preservation Officers with Compliance for Section 106 of the National Historic Preservation Act (2008), the NPS initiated formal consultation and coordination with the Maryland Historical Trust (MHT), the State Historic Preservation Office (SHPO) on November 15, 2021. The NPS held one Section 106 consulting parties meeting, which occurred on April 26, 2022. The NPS submitted a Section 106 Assessment of Effects (AOE) package to the SHPO in a letter dated July 18, 2022, recommending that the Plan will have no adverse effect on historic resources and the cultural landscape, but the implementation of the Plan could have an adverse effect on archeological resources. As funding becomes available to implement elements of the Plan, additional Section 106 consultation with the SHPO and Federally Recognized Tribes ("tribes) will be needed. However, the proposed undertakings in the Plan are unfunded and no site-specific planning has been done. Due to the lack of site-specific planning, the NPS cannot yet fully assess the potential effects of the undertakings on archeological resources. The Plan is part of the "nondestructive project planning" for these prospective undertakings, and as such does not "restrict the subsequent consideration of alternatives to avoid, minimize or mitigate [specific] undertakings adverse effects on historic properties" in accordance with 36 CFR § 800.1(c). Accordingly, the NPS finds that no archeological resources will be affected by the development of the Plan in accordance with 36 CFR § 800.4(d)(1).

Each element of the Plan will be subject to a separate Section 106 consultation as outlined in the 2008 Programmatic Agreement; and all work will be designed to meet The Secretary of the Interior's Standards for the Treatment of Historic Properties. The NPS will complete additional Section 106 compliance, including consultation with SHPO and tribes, submitted as a separate project (or separate projects) from the Plan as the precise locations of each element of the Plan are developed and designed. Section 106 compliance will be completed prior to any implementation work. Individual Memorandums of Agreements will be developed for these elements if there is a finding of adverse effect. The SHPO concurred with the NPS that the Plan will have no adverse effect on historic resources in a document dated August 24, 2022 (see Attachment C).

Tribal Consultation – Tribal consultation initiation letters were sent to the Accohannok Indian Tribe, Piscataway Conoy Tribe, Piscataway Indian Nation, Cedarville Band of Piscataway Conoy (Piscataway Conoy Tribe), Pamunkey Indian Tribe, Upper Mattaponi Indian Tribe, Rappahannock Tribe, Nansemond Indian Nation, Chickahominy Indian Tribe, Chickahominy Tribe Eastern Division, Monacan Indian Nation, Catawba Indian Nation, Delaware Nation, Absentee Shawnee Tribe of Indians of Oklahoma, and Shawnee Tribe on November 3, 2021. A Section 106 AOE package was submitted to the tribes on July 18, 2022. The consultation correspondence to the tribes is provided in Attachment C. The Catawba had no immediate concerns with regard to traditional cultural properties, sacred sites or Native American archaeological sites within the boundaries of the proposed project areas. However, the Catawba requested to be notified if Native American artifacts and / or human remains are located during the ground disturbance phase of this project. No comments were received from any other of the tribes; however, the Delaware Nation State Historic Preservation Office accepted the invitation for consultation.

Endangered Species Act, Section 7 Consultation - U.S. Fish and Wildlife Service (USFWS) – In accordance with Section 7 of the Endangered Species Act, an official species list was obtained through the U.S. Fish and Wildlife Service (USFWS)Information, Planning, and Consultation (IPaC) System on March 25, 2022, which identified the potential for the federally threatened northern long-eared bat (*Myotis septentrionalis*) and the federally endangered Indiana bat (*Myotis sodalist*) to be present at the Battlefield. Prior to and during the implementation period of the Plan, the NPS will complete Section 7 consultation with the USFWS and Maryland Department of Natural Resources Wildlife and Heritage Service (DNR) to identify activities included in the Plan that would have the potential to affect federally and state listed threatened and endangered species.

ALTERNATIVES CONSIDERED AND SELECTED

The EA analyzed two alternatives: (A) no action, and (B) action alternative (i.e., the Plan). Based on the analysis presented in the EA, the NPS selected Alternative B: Action Alternative (the NPS Preferred Alternative) for implementation. The selected alternative is described on pages 11-15 of the EA. The selected alternative will improve the cultural landscape integrity and ecological function of the Battlefield's diverse landscape mosaic. The selected alternative will also rehabilitate forest cover, improve riparian buffers, convert some open areas to grasslands or meadows, rehabilitate views through removing obstructive vegetation, and add orchard planting. The following summarizes Alternative B.

Forest Rehabilitation - Approximately 140 acres of woodland areas will be reforested in locations where substantial gaps in forest cover exist or where historic woodlots have been diminished. Forest rehabilitation provides ecological connectivity. Planted tree species will be from the Northeastern interior Dry-Mesic Oak Forest community and based on geographical location, such as the upland or floodplain community.

Water Quality Improvement - Water quality will be improved through enhanced riparian buffers and erosion mitigation. Riparian buffers will be maintained or enhanced adjacent to creeks, streams, and intermittent drainages as needed. In areas that include historic vistas, the improvements will use shrubs or grasses instead of trees in areas that include historic vistas.

Native Grassland and Meadow Establishment - Approximately 287 acres of additional native grasslands and meadows will be established through conversion of some hayfields and crop fields. These fields will be maintained through a prescribed burn program and monitoring, and ongoing control of invasive vegetation.

Agriculture - Approximately 824 acres of agricultural areas will continue to be maintained through special use permits or historic leasing. Agricultural fields where key battle-related actions occurred will

remain in agricultural use. These areas will continue to implement Nutrient Management plans and farmstead-specific Soil and Water Conservation plans. Farmsteads with hayfields and pastures will continue to follow soil and water conservation plan best management practices.

Orchards - Approximately two acres of the historic Mumma Farm orchard will be reestablished and approximately eight acres of the Piper Farmstead's existing orchard will be maintained.

Alternatives such as planting dwarf or nonfruiting varieties of trees will be considered for reducing the maintenance needs of the orchard. The Battlefield staff and the orchard cooperator will continue to manage the orchards through best management practices, such as deer population control, organic operation with low pesticide use, native bee population management, and cyclical mowing.

Mown Lawn - Mown lawns in select areas will be maintained, including tour road buffers, edges between road and agricultural fields, areas around the visitor center, Dunker Church, Mumma Cemetery, the Philadelphia Brigade Park, Sunken Road (Bloody Lane) and the Observation Tour, the Lee Headquarters Site, adjacent to the Burnside Bridge Overlook, as well as areas around the farmsteads, between farm buildings and structures and along internal fence lines.

Mumma Farmstead - The historic landscape will be rehabilitated by providing universally accessible routes; restoring missing farmstead vegetation; re-establishing the orchard; and rehabilitating the stone wall between the Mumma Farm and Roulette Farm to create a place for focused effort on public education programming.

Designed Landscapes - The Philadelphia Brigade Park will be rehabilitated based on recommendations in a future Philadelphia Brigade Park CLR. The Maryland Monument landscape will be rehabilitated by replacing tree gaps with sugar maples and maintaining the historical tree spacing pattern to define the monument setting. The Antietam National Cemetery landscape will be rehabilitated through implementation of the 2014 Antietam National Cemetery CLR, to include new plantings, selected vegetation removal, maintenance and establishment of new lawn areas, headstone preservation, and accessibility improvements to the cemetery lodge and within the cemetery grounds.

Viewsheds - Important visual connections will be re-established through clearing of obstructive successional vegetation and relocation of intrusive utility lines. Principal vantage points include the Visitor Center, Miller Meadow, Sunken Road (Bloody Lane), Observation Tower, Pry House, and Burnside Bridge. Views from the visitor center towards Sunken Road (Bloody Lane) and views north and west from the historic road trace will be rehabilitated through woody vegetation clearance. Views from the visitor center to the north will be rehabilitated by relocating these lines along MD Route 65.

Replica Historic Fencing - Approximately 15,000 linear feet of high priority replica historic fencing that supports interpretive operations will be maintained. High priority replica historic fencing is located at the Cornfield, along Dunker Church Road (historic Hagerstown Pike) and Sunken Road (Bloody Lane), and at the Burnside Bridge. Approximately 25,200 linear feet of lower priority replica historic fencing which primarily serves to delineate spatial relationships of the land, may also be maintained. Park staff will continue to review fencing needs based on interpretive and historic importance, maintenance requirements and existing conditions.

Maintenance of Other Landscape Elements - Other landscape elements will continue to be maintained, including roadbeds and edges, monuments, farm lanes, trails and routes, historic stone walls, potential witness trees, historic structures, and historic field edges and fencerows.

RATIONALE FOR DECISION

The NPS selected Alternative B for implementation because it best meets the purpose and need of the Plan, as it provides guidance on treatment for the entire battlefield cultural landscape, mitigates erosion, protects witness trees, and improves watershed stewardship.

MITIGATION MEASURES

The NPS places a strong emphasis on avoiding, minimizing, and mitigating potentially adverse environmental impacts and effects on cultural resources. Mitigation measures for the affected resources are outlined in the EA and are presented as Appendix A.

WHY THE SELECTED ALTERNATIVE WILL NOT HAVE A SIGNIFICANT IMPACT

As documented in the EA, the selected alternative has the potential for adverse and beneficial impacts on cultural landscapes (see EA pages 23-25); archeological resources (see EA pages 27-28); water resources (see EA page 30); vegetation (see EA page 32); wildlife and wildlife habitat (see EA page 34); and visitor use and experience (see EA pages 37-45). The NPS has determined that the selected alternative can be implemented without significant adverse effects, as defined in 40 CFR § 1508.27.

Changes to cultural landscapes will result from the addition of forests, grasslands, and meadows; removal of obstructive successional vegetation and the relocation of overhead utility lines; conversion of some existing croplands to the north of Sunken Road (Bloody Lane) to hayfields; rehabilitation of Philadelphia Brigade Park; and the introduction of new universally accessible routes at the Mumma Farmstead and the Antietam National Cemetery, which will alter land use, spatial organization, views and vistas, vegetation, buildings and structures, cluster arrangement, circulation, and small-scale features. The NPS will avoid or minimize impacts on cultural landscapes by undertaking maintenance, monitoring, and rehabilitation activities, as well as planning and design of new universally accessible routes at the Mumma Farmstead and the Antietam National Cemetery in a manner that is consistent with *The Secretary of the Interior's Standards for the Treatment of Historic Properties*.

Implementation of the selected alternative could result in adverse impacts on the Battlefield's documented and undocumented archeological resources. The entire Battlefield is an archeological site, but only approximately 48 percent of the Battlefield has been subject to some level of archeological survey. The intensity of survey within that 48 percent, however, is not comprehensive. Ground disturbance related to the Plan elements could disrupt or displace known and unknown archeological resources and result in a loss of integrity of the archeological resource, resulting in an adverse impact. Further analysis is necessary to determine the level of archeological survey effort needed to identify archeological resources within those portions of the Battlefield where proposed landscape changes could result in impacts. The NPS will minimize ground-disturbing activities to the extent practicable and avoid known archeological resources during landscape management and maintenance to the extent practicable. The NPS will conduct Phase IB archeological survey in those areas of the Battlefield that have not been subjected to the full suite of intensive archeological survey methods to identify archeological resources that could be impacted by landscape management and maintenance activities that have the potential for ground disturbance, could result in a loss of archeological integrity, and could result in adverse impacts on archeological resources. These surveys will take place where ground disturbance is proposed after exact project footprints are identified and prior to site work. Any such archeological studies and investigations will be carried out and evaluated for effect before construction and in consultation with the SHPO and tribes. If National Register of Historic Places (NRHP)-eligible or potentially eligible archeological resources are found to be present, the NPS would define the appropriate avoidance, minimization, and mitigation measures to be taken in consultation with the SHPO and tribes. If any Native American burials, cemeteries, or funerary objects are encountered, the NPS will contact federally recognized Tribes with affiliation in Maryland, in accordance with the Native American Graves Repatriation Act (NAGPRA). The NPS will establish Unanticipated Discoveries protocols for each landscape management or maintenance activity as part of the Section 106 documentation process prior to implementation of work. The NPS will follow the established Unanticipated Discoveries protocols in the event unanticipated archeological resources are encountered anywhere in the park as a result of ground disturbances.

The selected alternative will result in beneficial impacts on water resources by enhancing riparian buffers and mitigating erosion. Riparian buffers will be maintained or enhanced, through planting of trees and shrubs, adjacent to Antietam Creek, Mumma Spring, and Sharpsburg Creek, streams, and intermittent drainages as needed. The enhancement of riparian buffers will improve the ecological function of the Battlefield by filtering sediment and nutrients, reducing carbonaceous and nitrogenous biochemical oxygen demand (CBOD and NBOD, respectively), and sediment pollutants in the Antietam Creek watershed. The reduction of agricultural uses by an estimated total of 426 acres within the Battlefield will reduce the amount of manure, fertilizers, and pesticides used in the Battlefield. As a result, the Plan will decrease the potential for pollutants to affect Antietam Creek and its watershed. The conversion of 441 acres of agricultural fields to forest, grasslands, and meadows will reduce soil disturbance, and thereby potential erosion into waterways.

The selected alternative will result in beneficial impacts on vegetation by increasing the approximate land coverage of forests to 508 acres, native grasslands and meadows to 415 acres, and orchards to 10 acres while reducing the amount of agricultural area to 824 acres and the amount of mown lawn to 132 acres. Forest rehabilitation and grassland and meadow establishment will support the restoration of natural conditions, including the Northeastern Interior Dry-Mesic Oak Forest. As a result, wildlife will experience a greater range and expanded habitat.

The selected alternative will result in beneficial impacts on wildlife and wildlife habitat. The additional 140 acres of forest and additional 287 acres of grasslands and meadows will expand wildlife habitat. The conversion of agricultural fields to forest, grassland, and meadow uses will increase the areas available for wildlife within the Battlefield and maximize the natural resource value of these areas. The expanded forest will link currently disparate forested areas within the Battlefield. Expanded grasslands and meadows within the Battlefield will provide connections to areas that are currently fragmented. As a result, wildlife will experience a greater range and expanded habitat.

The selected alternative will result in beneficial impacts on visitor use and experience. The removal of obstructive successional vegetation and changes in vegetation patterns within important viewsheds will improve the ability of the landscape to represent historic conditions and enhance visitor understanding of it. The maintenance of high priority replica historic fencing will help preserve these features and continue to aid in visitor understanding of key areas of the Battlefield. The improved ecological function and new wildlife habitat through the proposed reforestation, enhanced riparian buffers and establishment of new grasslands and meadows could provide increased visitor opportunities for wildlife and nature viewing at the Battlefield. The re-establishment of the historic Mumma Farm orchard, the maintenance of the Piper Farmstead orchard, and the rehabilitation of the historic farming. The rehabilitation of Philadelphia Brigade Park, Maryland Monument landscape, and Antietam National Cemetery will enhance visitor understanding of these designed landscapes. New universally accessible routes at the Mumma Farmstead and Antietam National Cemetery will provide new user groups and individuals access to points of interest in the Battlefield and new educational opportunities.

CONCLUSION

As described above, the selected alternative does not constitute an action meeting the criteria that normally requires preparation of an environmental impact statement (EIS). The selected alternative will not have a significant effect on the human environment in accordance with Section 102(2)(c) of NEPA. Based on the foregoing, it has been determined that an EIS is not required for this project and, thus, will not be prepared.

APPENDIX A: MITIGATION MEASURES

Cultural Landscapes

The NPS will avoid or minimize impacts on cultural landscapes by undertaking maintenance, monitoring, and rehabilitation activities, as well as planning and design of new universally accessible routes at the Mumma Farmstead and the Antietam National Cemetery in a manner that is consistent with *The Secretary of the Interior's Standards for the Treatment of Historic Properties.*

Archeological Resources

The NPS will minimize ground-disturbing activities to the extent practicable. The NPS will also avoid known archeological resources during landscape management and maintenance to the extent practicable. The NPS will conduct Phase IB archeological survey in those areas of the Battlefield that have not been subjected to the full suite of intensive archeological survey methods to identify archeological resources that could be impacted by landscape management and maintenance activities that have the potential for ground disturbance, could result in a loss of archeological integrity, and could result in adverse impacts on archeological resources. These surveys will take place where ground disturbance is proposed after exact project footprints are identified and prior to site work. Any such archeological studies and investigations will be carried out and evaluated for effect before construction and in consultation with SHPO and the tribes. If NRHP-eligible or potentially eligible archeological resources are found to be present, the NPS will define the appropriate avoidance, minimization, and mitigation measures to be taken in consultation with the SHPO and tribes.

NPS protocols will be followed for the unanticipated discovery of human remains as a part of any project. If any Native American burials, cemeteries, or funerary objects are encountered, the NPS will contact federally recognized Tribes with affiliation in Maryland, in accordance with NAGPRA.

The NPS will establish Unanticipated Discoveries protocols for each landscape management or maintenance activity as part of the Section 106 documentation process prior to implementation of work. The NPS will follow the established Unanticipated Discoveries protocols in the event unanticipated archeological resources are encountered anywhere in the park as a result of ground disturbances.

Water Resources

The NPS will continue to develop Soil Conservation and Water Quality Plans (SCWQPs) and nutrient management plans for agricultural uses within the Battlefield. The NPS and/or its contractors will adhere to applicable BMPs to minimize the erosion of exposed soils and the corresponding pollution and sedimentation of downstream watercourses.

Vegetation

Obstructive vegetation removal will disturb areas and potentially offer the opportunity for invasive species to establish themselves. The disturbed areas will be re-vegetated or otherwise stabilized following the completion of implementation, which would reduce the potential for invasive species. Additionally, invasive species will be treated in accordance with an Invasive Plant Management Plan.

APPENDIX B: NON-IMPAIRMENT DETERMINATION

By enacting the National Park Service (NPS) Organic Act of 1916 (Organic Act), Congress directed the U.S. Department of the Interior and the NPS to manage units "to conserve the scenery and the natural and historic objects and wildlife therein and to provide for the enjoyment of the same in such a manner and by such a means as will leave them unimpaired for the enjoyment of future generations" (54 USC 100101). Congress reiterated this mandate in the Redwood National Park Expansion Act of 1978 by stating that NPS must conduct its actions in a manner that will ensure no "derogation of the values and purposes for which these various areas have been established, except as may have been or shall be directly and specifically provided by Congress" (54 USC 100101).

The NPS has discretion to allow impacts on Park resources and values when necessary and appropriate to fulfill the purposes of a Park (NPS 2006 sec. 1.4.3). However, the NPS cannot allow an adverse impact that would constitute impairment of the affected resources and values (NPS 2006 sec 1.4.3). An action constitutes an impairment when its impacts "*harm the integrity of Park resources or values, including the opportunities that otherwise would be present for the enjoyment of those resources or values*" (NPS 2006 sec 1.4.5). To determine impairment, the NPS must evaluate "*the particular resources and values that would be affected; the severity, duration, and timing of the impact…and other impacts*" (NPS 2006 sec 1.4.5).

This determination on impairment has been prepared for the selected alternative described in this Finding of No Significant Impact. An impairment determination is made for the resource topics of cultural landscapes, archeological resources, water resources, vegetation, and wildlife and wildlife habitat. These resources are considered fundamental to Antietam National Battlefield. An impairment determination is not made for visitor use and experience because impairment findings relate back to park resources and values, and these impact areas are not generally considered to be park resources or values according to the Organic Act and cannot be impaired in the same way that an action can impair park resources and values. This determination on impairment has been prepared for the action alternative described in Chapter 2 of the Antietam National Battlefield Landscape Management Plan EA.

Cultural Landscapes – The addition of forests, grasslands, and meadows; removal of obstructive successional vegetation and the relocation of overhead utility lines; conversion of some existing croplands to the north of Sunken Road (Bloody Lane) to hayfields; rehabilitation at the Philadelphia Brigade Park; and the introduction of new universally accessible routes at the Mumma Farmstead and the Antietam National Cemetery will result in changes to contributing land use, spatial organization, views and vistas, vegetation, buildings and structures, cluster arrangement, circulation, and small-scale features. However, implementation of the selected alternative will not diminish the integrity of the historic resources by undertaking maintenance, monitoring, and rehabilitation activities, as well as planning and design of new universally accessible routes at the Mumma Farmstead and the Antietam National Cemetery in a manner that is consistent with *The Secretary of the Interior's Standards for the Treatment of Historic Properties*. Because the selected alternative will result in no significant impacts on cultural landscapes and the NPS will undertake maintenance, monitoring, and rehabilitation activities and plan and design new features in a manner that protects and preserve the cultural landscape's condition and integrity, there will be no impairment to the park's cultural landscapes.

Archeological Resources – Proposed actions associated with the selected alternative will have no significant impact on archeological resources. The NPS will minimize ground-disturbing activities to the extent practicable. The NPS will also avoid known archeological resources during landscape management and maintenance to the extent practicable. The NPS will conduct Phase IB archeological survey in those areas of the Battlefield that have not been subjected to the full suite of intensive archeological survey methods to identify archeological resources that could be impacted by landscape management and maintenance activities that have the potential for ground disturbance, could result in a loss of archeological integrity, and could result in adverse impacts on archeological resources. These surveys will

take place where ground disturbance is proposed after exact project footprints are identified and prior to site work. Any such archeological studies and investigations will be carried out and evaluated for effect before construction and in consultation with SHPO and the tribes. If NRHP-eligible or potentially eligible archeological resources are found to be present, the NPS will define the appropriate avoidance, minimization, and mitigation measures to be taken in consultation with the SHPO and tribes. NPS protocols will be followed for the unanticipated discovery of human remains as a part of any project. If any Native American burials, cemeteries, or funerary objects are encountered, the NPS will contact federally recognized Tribes with affiliation in Maryland, in accordance with NAGPRA. The NPS will establish Unanticipated Discoveries protocols for each landscape management or maintenance activity as part of the Section 106 documentation process prior to implementation of work. The NPS will follow the established Unanticipated Discoveries protocols in the event unanticipated archeological resources are encountered anywhere in the park as a result of ground disturbances. Because the selected alternative will result in no significant impacts on archeological resources and the NPS will carry out all reasonable measures to protect and preserve their condition and integrity, there will be no impairment to the archeological resources.

Water Resources – The maintenance and enhancement of riparian buffers, reduction of agricultural uses by an estimated total of 426 acres; conversion of 441 acres of agricultural fields to forest, grasslands, and meadows; and re-establishment of two acres of orchards will result in changes in the Antietam Creek watershed and areas identified as wetlands. However, implementation of the selected alternative will not diminish the integrity of water resources by continuing to develop SCWQPs and nutrient management plans for agricultural uses within the park. The NPS and/or its contractors will also adhere to applicable Best Management Practices (BMPs) to minimize the erosion of exposed soils and the corresponding pollution and sedimentation of downstream watercourses. The NPS will also adhere to procedures set forth in Reference Manual #77-1: Wetland Protection in order to comply with NPS Director's Order #77-1: Wetland Protection and to avoid, minimize, and compensate for adverse impacts on wetlands. Because the selected alternative will result in no significant impacts on water resources and the NPS will carry out all reasonable measures to protect and preserve water quality and wetlands, there will be no impairment to the park's water resources.

Vegetation – The increase in the approximate land coverage of forests to 508 acres, native grasslands and meadows to 415 acres, and orchards to 10 acres; and reduction in the amount of agricultural area to 824 acres and the amount of mown lawn to 132 acres will result in changes to vegetation. However, implementation of the selected alternative will not diminish the integrity of vegetation by re-vegetating or otherwise stabilizing disturbed areas following implementation, which will reduce the potential for invasive species. Invasive species will be treated in accordance with the Invasive Plant Management Plan. Because the selected alternative will result in no significant impacts on vegetation and the NPS will revegetate or stabilize disturbed areas and treat invasive species, there will be no impairment to the park's vegetation.

Wildlife and Wildlife Habitat – The addition of 140 acres of forest and 287 acres of grasslands and meadows will result in changes to wildlife and wildlife habitat. However, implementation of the selected alternative will not diminish the integrity of wildlife and wildlife habitat because the selected alternative will increase the areas available for wildlife within the park, maximize the natural resource value of these areas, and provide connections to areas that are currently fragmented. Because the selected alternative will result in no significant impacts on wildlife and wildlife habitat, there will be no impairment to the park's wildlife and wildlife habitat.

Conclusion

The NPS has determined that the implementation of the NPS selected alternative will not constitute an impairment of the resources or values of Antietam National Battlefield. As described above, implementing the selected alternative is not anticipated to impair resources or values that are essential to

the purposes identified in the establishing legislation of the park, key to the natural or cultural integrity of the park, or identified as significant in the park's relevant planning documents. This conclusion is based on consideration of the park's purpose and significance, a thorough analysis of the environmental impacts described in the EA, the comments provided by the public and others, and the professional judgment of the decision-maker guided by the direction of the NPS Management Policies 2006.
