Dear Tribal Leader:

The National Park Service (NPS) is revising and reissuing its *National Register Bulletin 38:* Guidelines for Evaluating and Documenting Traditional Cultural Places (TCP Bulletin). NPS wishes to consult with Tribal Governments, Alaska Native Corporations, and Native Hawaiian Organizations in the revision of the TCP Bulletin. A copy of the Draft TCP Bulletin may be found here:

The National Register of Historic Places is the nation's official list of buildings, structures, objects, sites, and districts significant in American history, architecture, archaeology, engineering, and culture, including places significant for their association with cultural beliefs, customs, or practices. The TCP Bulletin was initially developed and issued in 1990 (with revisions in 1992 and 1998) to provide guidance on nominating properties believed to have traditional cultural significance for inclusion in the National Register. A traditional cultural place is a building, structure, object, site, or district that may be eligible for inclusion in the National Register for its significance to a living community because of its association with cultural beliefs, customs, or practices that are rooted in the community's history and that are important in maintaining the community's cultural identity. The TCP Bulletin formalized the term "Traditional Cultural Property" (now referred to as "Traditional Cultural Places"), but the National Register has included places of traditional cultural significance since its inception.

In response to requests for additional guidance on TCP identification, documentation, and evaluation from State and Tribal Historic Preservation Offices, federal agencies, and cultural resource professionals, the NPS held nationwide listening sessions from 2011 through 2013 to seek comments on the existing TCP Bulletin. NPS hosted webinars and participated in conferences, teleconferences, and meetings with Tribes, Native Hawai'ian Organizations, federal and state agencies, national and regional historic preservation organizations, and the general public. Many comments were received, most asking for clarification on TCP eligibility and TCP consideration in federal undertakings.

Based on those comments, as well as discussions with preservation partners, including the Advisory Council on Historic Preservation and the National Association of Tribal Historic Preservation Officers, the NPS has prepared a revised *Draft TCP Bulletin* and is relaunching its

effort to reissue the Bulletin. The *Draft TCP Bulletin* makes no change to how a "traditional cultural property" is defined but improves upon the 1999 version by using plain language and including numerous examples of National Register-listed TCPs.
