


#### **St. Croix National Scenic Riverway**



#### **Introduction to Fairy Falls Day Use Area**

54 acres Silver Creek creates a 50-foot waterfall into the gorge below Largely undeveloped National Park Service acquired in 1980 as part of the St. **Croix National Scenic** Riverway

#### **Current Status**


 The National Park Service rescinded the public closure that had been in place at Fairy Falls during the COVID-19 pandemic on December 19, 2022.
The closure was originally implemented due to the lack of parking and safety concerns related to high visitation the site was receiving during the pandemic.

NPS worked with the township to ensure parking would again be available in the area, and NPS closed the trails with the highest degree of erosion to allow for restoration to occur.



#### **Planning for the Future**

Began public planning process in fall 2021 Also working with Tribal partners and agency partners Developed two site options based on public input from 2021 and 2022 Will compare one or both options against current management (not the preference of the National Park Service)

## Site Option A

The NPS is required to consider the current management or "no-action" The current management is not the preference of the National Park Service. Later in the environmental review process, one or both options will be compared against an option of continuation of current management



## Site Option B

Visitor use would be focused on the waterfall, but access would be allowed across the site

 Interpretive signage and educational focus on waterfall

Continue to work with partners to provide parking and safe access

Seek a permanent parking solution

Primary visitor activities: visiting waterfall, photography, short hikes

Visitors would have more encounters with other visitors near the waterfall

## Site Option C

Visitor use would take place at the waterfall and be dispersed site-wide with a natural-surface loop trail

 Interpretive signage and educational materials dispersed across site

Continue to work with partners to provide parking and safe access

Seek a permanent parking solution

Primary visitor activities: visiting waterfall, longer walking loop Visitors may encounter others near the waterfall and also along loop trail system





**Activities that would occur under either Option:** Maintain a rustic and natural feel in the Day Use Area Continue partnerships with local communities and neighbors to provide parking and safe access Seek a permanent parking solution Allow use in Fairy Falls Day Use Area for daytime use only, from sunrise to sunset Prohibit overnight use, camping, and fires Provide improved maps and signs including safety and orientation information Provide opportunities for visitors with a range of skill levels and abilities

#### Activities that would occur under either Option, cont'd:


- Protect natural and cultural resources, such as invasive plant species management
  - **Continue engagement with Tribal partners**
  - Develop relationships and programs with community partners
  - Carry out occasional management or closures due to unsafe conditions or highly eroded trails
- Continue law enforcement patrols and maintenance activities to support a safe, clean day use area
- Allow deer archery hunting in Fairy Falls Day Use Area in accordance with state and federal laws

## Parking

 Currently, there is no parking available on Fairy Falls Day Use Area property

Riverway staff are seeking a permanent parking solution

Riverway staff are working with neighbors, community members, and partner agencies to identify options




#### Next Steps

#### Fairy Falls Day Use Area Site Planning Process

The National Park Service is exploring opportunities for improving safety, protecting the natural environment, and enhancing visitor experiences at the Fairy Falls Day Use Area, located near Stillwater, Minnesota.



The Fairy Falls Day Use Area is a 54-acre natural area located in Stillwater Township. Deep ravines and steep bluffs surround Silver Creek as it passes through a marsh on its way the St. Croix River. The area has a long history of human use and its ecological diversity provides habitat for a variety of plants and animals. Fairy Falls Day Use Area is currently closed to the public due to lack of safe visitor access and deteriorating social trails along steep slopes.

In October and November 2021, we invited public comments to gather input before concepts or ideas for the future of Fairy Falls Day Use Area are formally developed. We invited comments from the public about:

- Identifying safe access and designated parking
- Improving or rerouting trails
- Enhancing visitor experience
- Protecting the natural environment
