### Notice of Scoping Bryce Canyon National Park, Utah Rehabilitate Failing Park Sewage System Environmental Assessment July 2009

Dear Friend of Bryce Canyon National Park:

The National Park Service (NPS) is preparing an Environmental Assessment (EA) to rehabilitate a failing park sewage system. The EA is needed in order to evaluate potential impacts to natural and cultural resources from proposed project activities, including impacts to Utah prairie dog habitat. The NPS is soliciting comments from the public to help identify issues associated with this project and develop alternative resource protection approaches that will be evaluated in the EA.

The Rehabilitate Failing Park Sewage System EA will be prepared in compliance with the National Environmental Policy Act (NEPA) to provide the decision-making framework that 1) analyzes a reasonable range of alternatives to meet project objectives, 2) evaluates potential issues and impacts to park resources and values, and 3) identifies mitigation measures to lessen the degree or extent of these impacts.

# Why does Bryce Canyon need to rehabilitate the park sewage system?

The park's existing sewage collections system includes deteriorating portions originally built in 1958 of clay pipe. These sections of the system and appurtenant manholes are deteriorating into pieces that regularly clog the system and cause raw sewage to back up, leak out of the system into the groundwater, and spill onto the ground from backed-up manholes.

This project will replace broken and deteriorating portions of the park's sewage collection system, demolish two failed small independent septic tank and leach field systems and replace them with piped connections to the park's main sewage collection system. This project will also recondition one of the sewage treatment lagoon cells, install an inline grinder pump on the main sewer pipe feeding the treatment lagoons, install a small wash station and install a water supply line from the visitor's center to the existing dump station located at the lagoons.

# Have preliminary issues and alternatives been identified?

The NPS has identified preliminary issues related to activities associated with rehabilitation of the park's sewer system that will be analyzed through the EA process. Issues and/or alternatives identified through public scoping will also be addressed in the EA.

The EA will describe and analyze:

- methods to recondition the park's main sewage system;
- methods to protect wildlife, sensitive species and meadow habitats during construction activities;
- effects on wildlife and threatened/endangered species; and
- effects on water quality.
- effects on cultural resources

#### Why involve the public?

The National Park Service encourages public participation throughout the NEPA process during which the public has two opportunities to formally comment on the project: once during initial project scoping and again following release of the Rehabilitate Failing Park Sewage System EA.

We are currently in the scoping phase of this project, and invite you to submit your written comments online at the NPS Planning, Environment, and Public Comment website at <u>http://parkplanning.nps.gov/</u>. If you are not able to submit comments electronically through this website, then you may also submit written comments using the attached comment form to this scoping notice. These comments will be considered during preparation of the Rehabilitate Failing Park Sewage System EA. We look forward to hearing from you!

#### What's next?

Once the NPS has received and reviewed the scoping comments, alternatives will be developed and incorporated into the document. The Rehabilitate Failing Park Sewage System EA is expected to be available for review in the Spring 2010.
