NOTICE OF 30-DAY PUBLIC COMMENT PERIOD Belnap and Big Spring Pipeline Allotments Grazing Permit Renewal Environmental Assessment

ST. GEORGE, Utah— The Bureau of Land Management (BLM) and the National Park Service's (NPS) Grand Canyon -Parashant National Monument (GCPNM) have prepared an Environmental Assessment (EA) (DOI-BLM-AZ-A030-2023-0002-EA/ PEPC-111150) for the Big Spring Pipeline and Belnap Grazing Permit Renewal (see attached Overview Map). This EA is a public document and is available for review and comment. The EA analyzes three alternatives: Alternative A (Proposed Action) – Combine the Belnap and Big Spring Pipeline Allotments, extend the season of use for the Belnap pastures, implement a nine-pasture rotation system, and rename and renew the permit for the combined Big Spring Pipeline Allotment. Alternative B (No Action) – Renew the Permit for Belnap and Big Springs Pipeline Allotments with no changes in season of use or combination of allotments. Alternative C (No Grazing) – Reissue a 10-year term permit for the Belnap and Big Spring Pipeline Allotments with zero authorized animal unit months.

Please review the EA for further details. The EA is available for a 30-day public comment period ending at close of business (4:30 p.m., MDT) on June 26, 2023.
