
What is a National Heritage Area?

"A National Heritage Area is a place designated by Congress where natural, cultural, historic and scenic resources combine to form a **cohesive, nationally distinctive landscape** arising from patterns of human activity shaped by geography. These patterns make National Heritage Areas **representative of the national experience** through the **physical features** that remain and the **traditions** that have evolved in them. **Continued use** of National Heritage Areas by people whose traditions helped to shape the landscapes enhances their significance."

Completion of feasibility study


Public involvement in planning

Criteria

As a place/landscape/area

1. An area has an assemblage of natural, historic, or cultural resources that together represent distinctive aspects of American heritage worthy of recognition, conservation, interpretation, and continuing use, and are best managed as such an assemblage through partnerships among public and private entities, and by linking diverse and sometimes noncontiguous resources and active communities;

2. Reflects **traditions, customs, beliefs, and folklife** that are a valuable part of the **national story**;

3. Provides **outstanding opportunities** to conserve natural, cultural, historic, and /or scenic features; Provides **outstanding** recreational and educational **opportunities**;

4. The resources important to the identified theme or themes of the area **retain a degree of integrity** capable of **supporting interpretation**;

Criteria

As a public/private partnership and community assistance program

5. Residents, business interests, non-profit organizations, and governments within the proposed area are involved in the planning, have developed a **conceptual financial plan** that outlines the roles for all participants including the federal government, and have **demonstrated support** for designation of the area;

6. The proposed local coordinating entity and units of government supporting the designation are willing to **commit to working in partnership** to develop the heritage area while **encouraging state and local economic activity**;

7. A conceptual **boundary map** is supported by the **public**;
