Boogie

So far the newsletter seems quite accurate

Meli

- Follow-up with policy and rules including settlement rules for visitation.
- National Park Service is doing a good job.

lvy

- Concerned about visitation
- Keep Kalawao the same and keep Kalaupapa the same to each time period.
- Keep the Saint Damien and Mother Marianne story alive.

Pauline

Keep the age limitation the same.

Father Felix

- I feel the age restriction should be 14 years old to be able to bring in entire youth groups. (Lowering the age limit).
- Keep in mind and never lose the fact that we are on sacred ground.

Gloria

- Not in favor of changing the age limit rule now or currently. In the past it was changed but was abused.
- The youth and some others were not following the other visitation rules, such as skateboarding.
- When there is no longer a patient community it would be okay to change the age limit rule.

Meli

When there are no longer patients, the age limit policy would come under the National Park Service; it would be up to the National Park Service to decide the age limit. Keep the same age limit (16 years and older) even when patients are gone.

Pauline

Continue age limit even when patients are gone.

Gloria

• Keep the age limit now, can change afterwards. It's National Park Service's kuleana.

Winnie

- Doesn't care about the age limit.
- She mentioned that earlier there was a long discussion about Department of Hawaiian Home Lands and National Park Service cooperation. It was supposed to also address educating the people about Native Hawaiian culture. Taro production was an example.

Sol

 Hawaiian legislature created Kalawao County. It's up to the people to provide input to the legislature regarding jurisdiction of Kalawao County. It's not a National Park Service or patient decision; it's up to the legislature.

Gloria

She wants to maintain Kalawao County as a separate county. Federal funds contribute to the county.

Julie

- Need public relations marketing person especially for topside contacts.
- Missionaries can volunteer, paint, and clean yards.
- Need a National Park Service contact as well. Link to Maui and Moloka'i visitor and tourism association websites.
- Rules and regulations should be known and there should be consideration of privacy of patients.
- Regarding the pali trail, inform people of the condition of the trail so they understand what they are getting into.
- Inform people of conditions at Kalaupapa, limited access, and lack of medical service for visitors.

Val V.

- preservation of historic structures is a sustainable practice as opposed to construction of new buildings.
- Global warming is an issue. National Park Service should do what it can to mitigate impacts.
- It is projected that there will be a 6 foot sea level rise this century.

Carol

- Need a real infirmary with a first aid station
- There needs to be a better effort to provide information, such as a kiosk or a welcome messaging area.
- There needs to be better access for all including those who are hearing or sight impaired.
- Need to help families find grave markers.
- Need to respond to family requests.
- Clear overgrowth of invasive species, which are over the rock walls and cemeteries.
- There should be opportunities to educate youth groups to connect to land, culture and traditions.
- The information and education should cover both Hawaiian and leprosy eras.

Randall

- Main points brought up in the community meeting were talked about in the newsletter.
- There is so much transition going on in the community and he is worried about the patients right now.
- There is state turmoil with funding.
- Need to focus on the present.
- Want National Park Service to work closer with the state.
- Patients are the most important and delicate resource.

Richard

- The spirituality and serenity of Kalaupapa comes from the people, including the past.
- There is uplift to the community to have projects related to preservation.
- Buildings are tangible and contribute to the story.

Scott

- There needs to be a focus on education.
- There should be a visitor center topside.
- It would be good to incorporate patient stories now.
- The community topside wants to know what's happening at Kalaupapa.
- It would be good to have patients provide interpretive information.
- Also could use buildings at Kalaupapa for interpretation and education.

Sister Rose

- "I commend the report (newsletter); it's very inclusive."
- Factual information Mother Marianne came approximately 120 years ago. 61 of our sisters have served here in Kalaupapa.
- Bishop Home could be a future meditative place for all denominations.
- Educate the young people about Kalaupapa.
- "I never realized until I joined the convent what Kalaupapa was all about."
- Youth groups, publications, teachers, and outreach.
- Have an educational site.
- Don't bar youth from this place. They can be well chaperoned.
- Educate not just topside but nationwide.
- Kalaupapa could be for more people than now. "Not to protect for our own use."

Sister Theresa

- Agrees with a lot of the comments, including that residents want to keep it as is.
- In the future don't limit access to Kalaupapa. National Parks are for everyone.
- National parks have an emphasis on education including history.
- From the religious point of view, Saint Damien and Mother Marianne make this place holy.
- Would like for religious groups to come here.
- Kalaupapa is a place of sacrifice as related to Saint Damien and Mother Marianne and the patients.
- Story of Mother Marianne is not as emphasized as Saint Damien, but should be told.
- Push education.
- National Park Service is doing a great job.

Liz

- Even though I read about Kalaupapa, it wasn't until I traveled here that I understood it.
- An educational station at the top of the pali to distribute valid information about Kalaupapa is needed now.
- Information regarding access, regulation, and history is pivotal.
- Spiritual reaction to both here and Carville is similar.
- Have Native Hawaiians leading tours and giving interpretation to field questions with accuracy and authority.
- Provide both walking and driving tours.
- Liz has fielded requests regarding buried relatives and has experience with locating medical records and cemetery grave markers.

Boogie

No paved road to Kalaupapa.

Meli

- Keep Kalawao and Kalaupapa the same as they are now.
- Saint Philomena and Saint Siloama Churches keep them clean, take care of Saint Damien's grave, and keep all the grave yards clean.

Agrees with comments about Saint Damien and Mother Marianne regarding education and spirituality.

- Agrees with Father Felix and Sister about importance of place and what it represents the sacrifice that occurred.
- Kalaupapa is a "cradle of Christianity."
- We can teach the world.

- Pass on lessons by patients and the church.

Father Felix

- In the past years, we've lost Richard, Bernard, others.
- Put the stories of the remaining patients on tape to preserve them for future generations.

Sol

- Regarding the Environmental Assessment for the memorial asked for clarification about the process and evaluation of the two sites - Baldwin Home and Judd Park. Is Judd Park an alternative location and how was that decided.
- There should be caution in discussing the design of the memorial, because it has not yet been discussed within the team.

Carol

- Asked about the development of the trail topside.
- A future growth of the curatorial program is an important component to the General Management Plan.

Meli

Keep or include maintenance of Father Damien and Mother Marianne's graves.

Gloria

Agrees with Boogie that there shouldn't be a paved road to Kalaupapa down the pali.

- Homesteaders had to give up that land; therefore for 50 years (because of the lease) they will not be allowed?
- For the alternatives development, suggests that National Park Service follows the ORMP (Ocean Resource Management Plan) which covers both mauka and sea
- Use aha moku and aha kiole structures so people become part of decision-making; therefore, be part of the management mechanism
