

Thank you for your August 10, 2009 request to initiate consultation in compliance with section 7 of the Endangered Species Act of 1973, as amended (16 U.S.C. 1531 et seq.), for the National Park Service's (NPS) Abandoned Mine Lands Closure (AMLC) program in four parks in Arizona: Coronado National Memorial, Grand Canyon National Park, Organ Pipe Cactus National Monument, and Saguaro National Park. We have reviewed the information you provided and have concluded that we have not received all of the information necessary to initiate section 7 consultation, as outlined in the regulations governing interagency consultations (50 CFR §402.14), on the AMLC program. To complete the initiation package, we will require the following information:

- 1. A Biological Assessment (BA) that clearly describes the project locations, including maps; a complete project description, including equipment, timing, methodology, conservation measures, etc.; a description of threatened and endangered species or critical habitats that occur in the project areas; and anticipated effects to those resources as a result of the project.
- 2. Reports of any surveys, research, or monitoring that will inform our evaluation of impacts to listed species and/or critical habitat within the project areas.
- 3. A determination of effects for all listed species support by the assessment in the BA.

The formal consultation process for this project will not begin until we have received all of the information, or a statement explaining why that information cannot be made available. We will notify you when we have received this additional information; our notification letter will also outline the dates within which consultation should be complete and the biological opinion on the proposed action will be delivered.

At this time we are providing comments as requested in your Project Scoping Brochure. These comments are intended to help you develop the BA, Environmental Assessment, and other documents associated with the AMLC program.

Because the project description in the Scoping Brochure does not specify the exact locations where mine closure work will occur within these four parks, we are providing a general summary of listed species for each park that may be affected. The potential for effects to a given species will depend on the location, type of mine, type of survey or investigation, type of closure, and accessibility of the site. Not all of these species will necessarily be affected. For example, some mines may produce a surface or flowing water source that supports aquatic or amphibian species. However, if none of the mines that are part of this project produce surface waters and associated riparian vegetation, then it is unlikely that any of the aquatic or amphibian species will be impacted. Some effects to species may occur if helicopters are used to implement the project, but these impacts may not be an issue if materials are backpacked in. If significant preparation of the site is needed prior to closure, runoff and sediments may affect species in the same drainage even though they are some distance from the project site. The following is a list of species, by Park, that we believe have some potential to be affected by this project:

Saguaro National Park:

- Chiricahua Leopard Frog (Lithobates [Rana] chiricahuensis) Threatened
- Gila Topminnow (Poeciliopsis occidentalis occidentalis) Endangered

We have the following recommendations regarding project implementation:

- Survey mines proposed for closure for use by listed species and other wildlife.
- Based on surveys or, if surveys are lacking, the potential for species occurrence, implement seasonal construction limitations to avoid sensitive seasons such as nesting, breeding, migration, and seasonal occupancy of areas.
- Consider not closing mines that show wildlife use if human health and safety can be maintained.
- Use an appropriate closure design that will accomplish the objectives of the project, while maintaining wildlife habitat values.
- Post-construction monitoring is essential. Mine closures that implement wildlife
 conservation measures are not useful unless follow-up monitoring is conducted to assess
 the success and effectiveness of the measure. It is imperative that we learn from this
 project so that similar efforts in the future are effective and appropriate.
- Implement Best Management Practices to reduce the footprint of these projects on the landscape. These should include using the least disturbing access techniques and routes, noise reduction, runoff and sediment control, containment of contaminants, etc.

We appreciate the opportunity to comment on this proposed action and look forward to working with you through consultation to minimize impacts and maximize benefits to listed species. In addition, we commend the efforts of the National Park Service in implementing this program in a manner that conserves the unique wildlife and plant communities of Arizona. The Arizona Game and Fish Department (Department) has reviewed the notification for preparing an Abandoned Mine Lands Closure Plan/ Environmental Assessment (EA). The Department commends the National Park Service for seeking a "blanket" EA for their abandoned mine lands closure efforts. Ideally, this will speed the process for implementing closures on NPS lands. The Department has the following comments for your consideration in preparation of the EA.

In the EA, it is important to evaluate all the methods that could be chosen to close a mine to ensure that a single closure method is not chosen as a "blanket". Each site is unique and will need to be evaluated prior to choosing a closure method. Each site would need to evaluate the species using the mine, seasonal uses, and availability of other sites for the species using the mine to determine the type of closure needed. The EA should also address the "timing" or scheduling of closures, especially those closures that involve exclusion of bats. Lastly, not all mines should be deemed hazardous purely because it is a human-made structure, and therefore, "No action" needs to remain an alternative for some sites.

The EA also needs to include maintenance measures. Some sites will undoubtedly require maintenance of the closure. The EA should address how this activity will be covered, including sites in a wilderness setting. In addition, the EA should address adaptive management methods should a closure need to be modified (i.e. State of Texas Mine on the Coronado National Memorial or Stanton Cave in Grand Canyon National Park).

Lastly, the Department recommends including a discussion of White-nosed syndrome and how management would address the disease should it appear in the West. Some agencies in the eastern U.S. are considering whether to seal sites where white-nose has been recorded.


