Dear Mr. Hill:

Thanks for the opportunity to comment on the proposed boundary revision for Olympic National Park.

I'm writing today in support of the proposed land transfer at Umbrella Bay north of Lake Ozette. My support is due to the critical sockeye habitat this addition will provide. In addition, the former owner had decided the property did not fit within its long-term timberland objectives as it was isolated and had environmental constraints. They listed it for sale in 6 parcels. To avert the threat of conversion of these properties to residential development, Cascade Land Conservancy borrowed funds to purchase and temporarily hold the land between the lake and the Hoko-Ozette Highway. The property makes sense as an addition to the Olympic National Park and is consistent with Olympic National Park's 2008 general management plan. This piece is an obvious habitat conservation addition to the park. As previously mentioned, this expansion is a critical piece toward efforts to increase the population of threatened Ozette sockeye salmon recovery. The property identified for transfer supports critical habitat along

Umbrella Creek and spawning and rearing ground for Sockeye, a species that is fighting for survival due to habitat loss and stock depletion. Addition to the park for permanent protection is beneficial to this federally listed species.

Please move forward in the effort to acquire this property as an addition to Olympic National Park. In addition, please include me on any future communications on this topic.

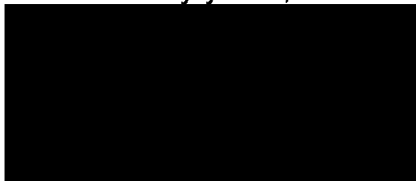

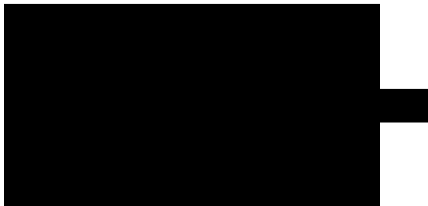
Mr. Hill,

I realize I am late with this letter but i hope that you will still consider my comments in this matter. I encourage the National Park Service to proceed with this important land acquisition. As you know, this is the first opportunity for a willing-seller acquisition within the areas identified in Olympic National Park's 2008 General Management Plan FEIS (GMP), which received full NEPA review and extensive public comment. In fact, many aspects of this 240-acre parcel make it an exemplary willing-seller acquisition. This is a great model for the NPS service to use in the future and this one will set the tone.

The parcel was originally offered for sale for private residential or recreational development. It was purchased in good faith by the Cascade Lands Conservancy with the expectation that it would be acquired by the NPS as funds became available. And it meets the qualifications outlined in the GMP for willing-seller acquisition.

The parcel is strategically important for protecting a federally threatened national park resource, the Ozette sockeye. NOAA's Ozette sockeye recovery plan identified Umbrella Creek as a priority one habitat for sockeye spawning. Umbrella Creek also offers the best chance in the Ozette watershed for a sockeye stream restoration, which could eventually lead to restored habitat for delta spawning. Other fish species would benefit from this acquisition as well. It's worth noting that Lake Ozette and the Ozette River host the greatest fish diversity of any watershed in Olympic National Park, and all salmon stocks there are currently in decline, primarily due to incompatible land uses in the surrounding watershed.

This email is in support of the proposed Umbrella Creek addition to Olympic National Park. As a native to the Pacific Northwest, whose life was shaped by the land, water, and wildlife here, I strongly voice my desire that Olympic National Park acquire the proposed Umbrella Creek addition.

Living next to Olympic National Park, and experiencing the beauty and grandeur of Lake Ozette, along with its surrounding forests and tributaries, has been inspiring, invigorating, and rejuvenating to me all my life and to countless others. As time goes on, our unique natural heritage, including our salmon runs, pristine waters, and old-growth ecosystems are becoming more valuable and their conservation more necessary as development expands and global environmental impacts increase.

The Umbrella Creek addition is important to me and valuable to the public for several reasons: Umbrella Creek was identified as a top priority stream for listed salmon in the Lake Ozette by NOAA, the area of the proposed addition has already been identified as appropriate for expansion in the NPS General Management Plan, which received extensive public review, and the parcel was purchased by the Cascade Land Conservancy to save it from residential/recreational development with the understanding that it would be transferred to Olympic National Park when funds became available.

In addition, please consider that the Ozette Lake watershed has the highest fish diversity in Olympic National Park and all fish populations in the watershed are in decline. It is the park's responsibility to recover listed threatened and endangered species within its jurisdiction. Clearly, the proposed acquisition would be an important step toward recovery of Ozette sockeye.

Finally, it's worth noting that this opportunity is based on a willing-seller acquisition, which means that the current owners want this land to be held in the public trust. While there may be opposition to Park expansion, the benefits to the public at the local, regional, and national levels far outweigh the costs to those who seek to convert this land for economic gain or want another playground for power sports or other activities which spoil the land's natural qualities.

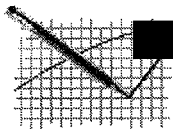

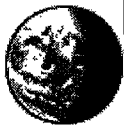
