For the proposed project actions to be within compliance requirements during construction and/or project implementation, the following mitigations must be adhered to:



Project Description: Homeowners Andrew and Erin Davenport will make necessary repairs to the existing home located at 5521 Foresta Road in El Portal. The proposed repairs will be located within the dimensions of the foot print of the existing building in essentially the same location. Square footage (926 sq. ft.) and number of bedrooms (n=2) are to remain unchanged. Relevant Mariposa County building permits will be obtained, and all work will be completed by licensed professionals to ensure quality. Repairs are to include upgrades of the foundation, siding, insulation, windows, doors, HVAC, and plumbing systems.







Proposed Residence Façade (Southern Elevation)
