After reading about the four preliminary alternative concepts, are there certain aspects or elements of the alternatives that you would change? Do you have ideas for other concepts? Briefly explain.

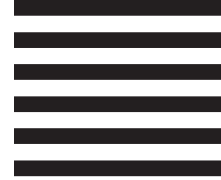
After reviewing the draft management zone maps associated with each preliminary alternative concept, do you feel the zoning reflects the intent of the alternative? If not, why not?
